## **RESOLUTION:**

A) RESCINDING THE "THIRTY-MINUTE TIME LIMITED PARKING" ZONE ON THE WESTERLY SIDE OF EAST SELBY LANE COMMENCING AT A POINT 80 FEET SOUTHWESTERLY OF THE INTERSECTION OF EL CAMINO REAL, STATE HIGHWAY 82, AND EXTENDING NORTHEASTERLY A DISTANCE OF 53 FEET, MORE OR LESS THAT WAS PREVIOUSLY APPROVED BY RESOLUTION NO. 067695 ON DECEMBER 6, 2005; AND

- B) RESCINDING THE "PASSENGER LOADING" ZONE ON THE NORTHERLY SIDE OF EAST SELBY LANE COMMENCING AT A POINT 70 FEET EASTERLY OF THE INTERSECTION OF EL CAMINO REAL AND EXTENDING EASTERLY A DISTANCE OF 44 FEET, MORE OR LESS THAT WAS PREVIOUSLY APPROVED BY RESOLUTION NO. 068091 ON JUNE 20, 2006; AND
- C) ESTABLISHING A "NO PARKING" ZONE ALONG EAST SELBY LANE IN THE UNINCORPORATED REDWOOD CITY AREA

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507 et al. and Section 7.30.010 et al. of the San Mateo County Ordinance Code allow the Board of Supervisors to prohibit or restrict the stopping, parking or standing of vehicles by resolution or ordinance; and

WHEREAS, Sunrise of Redwood City, a new senior living facility, seeks restricted parking in front of their facility located at 1 Selby Lane, in the unincorporated Redwood City area to allow emergency vehicle parking; and

WHEREAS, this Board authorized previous parking restrictions for a thirty minute time limited parking zone and a passenger loading zone which were removed

during the reconstruction of the sidewalk in connection with the construction of Sunrise of Redwood City and these restrictions are no longer needed; and

WHEREAS, the Menlo Park Fire Department recommends that a "No Parking" zone be established so that emergency vehicles can service this facility easily; and

WHEREAS, the Director of Public Works has recommended that a "No Parking" zone be established as noted herein; and

**WHEREAS,** this Board has reviewed and concurs with the recommendation of the Director of Public Works.

## NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

- The "Thirty-Minute Time Limited Parking" zone established per Resolution No.
   067695, on December 6, 2005 at the following location shall be rescinded:
   On the westerly side of East Selby Lane commencing at a point 80 feet east of the intersection of El Camino Real, State Highway 82, and extending northeasterly a distance of 53 feet, more or less.
- The "Passenger Loading" zone established per Resolution No. 068091 on June 20, 2006 at the following location shall be rescinded:
   On the northerly side of East Selby Lane commencing at a point 70 feet easterly of the intersection of El Camino Real and extending easterly a distance of 44 feet, more or less.
- 3. "No Parking" zones are declared to exist at the following locations:

- A.) On the westerly side of East Selby Lane (Road 409) commencing fifty feet (50.0') east of the center line of State Highway 82, El Camino Real, extending along the curve onto Markham Avenue, a distance of 279 feet, more or less.
- B.) At the intersection of Markham Avenue, Durham Avenue, and East Selby lane commencing two hundred eighty-five feet (285.0') northeast from the center line of El Camino Real, extending around entire island, a length of one hundred twenty five feet (125.0'), more or less.
