## AMENDMENT 3 TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND GENUENT GLOBAL LLC.

THIS AMENDMENT TO THE AGREEMENT, entered into this 12<sup>th</sup> day of September 2023, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and GENUENT GLOBAL LLC. hereinafter called "Contractor";

## WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for the purpose of supporting the Quality Assurance testing services for the Assessor Property Assessment System (APAS) project (BOS Resolution # 077609); and

WHEREAS, on July 21, 2020, the parties entered into an Agreement for the services of Deepa Narayan, to support the quality assurance testing activities for the Assessor Property Assessment System (APAS) project on July 21, 2020 through June 30, 2022 in the amount of \$340,956; and

WHEREAS, on June 28, 2022, the parties amended the Agreement to extend the term from July 21, 2020 through June 30, 2022 to July 21, 2020 through March 31, 2023 and increased the amount payable by \$100.370 for an amount not to exceed \$441.326; and

WHEREAS, on March 28, 2023, the parties amended the Agreement to extend the term from July 21, 2020 through March 31, 2023 to July 21, 2020 through September 30, 2023 and increase the amount by \$83,982 to an amount not to exceed \$525,308; and

WHEREAS, the parties now wish to further amend the Agreement to extend the term from July 21, 2020 through September 30, 2023 to July 21, 2020 through January 31, 2024 and increase the amount by \$58,568 to an amount not to exceed \$583,876.

## NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3. Payments: of the Agreement is replaced in its entirety as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner

specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed Five Hundred Eighty-Three Thousand Eight Hundred Seventy-Six dollars (\$583,876). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

- 2. Section 4. Term: of the Agreement is replaced in its entirety as follows:

  Subject to compliance with all terms and conditions, the term of this Agreement will be from July 21, 2020, through January 31, 2024.
- 3. Exhibit B: of the Agreement is replaced in its entirety as follows:
  In consideration of the services provided by Contractor described in Exhibit A and subject to the terms of the Agreement, County shall pay Contractor based on the following fee schedule and terms:

The combined total hours for this contract will not exceed 7103 hours. Invoices will be submitted based on hours worked (\$82 per hour rate till June 30, 2022, \$88 per hour rate from July 01, 2022, through January 31, 2024), during each two-week period. Terms are net 30 days after invoice is approved.

4. All other terms and conditions of the agreement dated July 21, 2020, between the County and Contractor shall remain in full force and effect.
