**RESOLUTION ADOPTING THE TAX RATES ON THE SECURED ROLL FOR FISCAL  
YEAR 2023-24**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, pursuant to Government Code Section 29100, the Board of Supervisors is required to adopt by resolution the tax rates on the secured roll on or before October 3<sup>rd</sup>; and

**WHEREAS**, since the passage of Proposition 13, the County is also required to set tax rates for general obligation bonds approved by the voters for taxing jurisdictions within the County; and

**WHEREAS**, the Controller has calculated the tax rates for Fiscal Year 2023-2024 based on the secured assessed valuation of \$ 295,358,532,236; and

**WHEREAS**, the 2023-24 tax rates to be adopted by the Board are set forth in the attached schedule for adoption by the Board; and

**WHEREAS**, if the tax rates are not set, the taxing jurisdictions will not be able to meet their required debt service requirements.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of Supervisors does hereby set the tax rates for the secured roll, in the number of dollars levied for each fund upon \$100 of assessed valuation of the taxable property of San Mateo County for the Fiscal Year 2023-24, in the sums and items and amounts as particularly set forth in the papers attached hereto and marked as Schedule "A".
