

Measure K was identified as an area in which changes could be made to align funding with these priorities







Methodology: Resident Engagement

Listening Sessions

Eight sessions across the county to:

- listen to residents needs
- understand services
- inform how Measure K allocations

Data gathering activities:

- welcome marbles
- welcome cards
- small group discussions
- money marbles

345 residents participated

Survey






Race/Ethnicity



Reach: Survey Respondents vs. Census Data



Income


Comparison of Household Incomes Distribution: Survey Respondents vs. Census Data

Methodology: CBO and County Data

CBO Engagement

- CBO Summit implemented by another consultancy
- CBOs separated into their own small group discussions at listening sessions
- Government staff (e.g., city staff) were included in the CBO groups



County Data

County staff asked a variety of County Departments to share what they see as community needs and to provide ideas on services to help resolve those needs.

Findings focus on residents needs expressed in the listening sessions and survey.

CBO and County Data supplement the findings where their input aligns with resident-based themes.



Findings: Overarching Themes

Topic Agnostic

“Needs are Needs”

Residents do not think about their needs in relationship to funding streams.

Filtering the needs and ideas for services to be restrictive to what Measure K could fund in reporting would be disingenuous to what the community shared and hinder the trust built over the course of this engagement.





Key Themes:

The community voices a strong desire for accessible, affordable options that extend beyond school hours, highlighting the significance of weekday, weekend, and summer programs. Given the area's high cost of living, it's imperative that these services cater to families across all income spectrums.








Top 5 Concerns for Families with School-Aged Children





HHI \$75K or less vs. Countywide




Financial Status, Beyond Income

Emergency Preparedness: Listening Sessions

Residents call for a Countywide Emergency Communications Plan that:

- considers the **unique geographic circumstances** of the diverse county landscape
- is developed through robust **community outreach** on macro (city-level) and micro (block-level) scales
- provides **information on resources** accessible before, during, and after emergency
- is widely spread in **multiple languages**
- **leverages** businesses, people, their **skillsets**, and **equipment**
- helps neighbors determine **who can help** provide what support during an emergency and **who might need support**
- considers **cultural norms** when helping communities plan



Emergency Preparedness: Survey

Before an Emergency:

“Thinking about an emergency situation you have experienced, what would have helped you better prepare?”

55% a system of warning the community

49% knowing where to go for shelter in advance

46% knowing what type of supplies you need and where to get them in advance


41% knowing in advance who to call in an emergency


During an Emergency:

Top needs during a disaster or emergency situation




After an Emergency:

Housing & Homelessness: Listening Sessions



Key Themes:

1. Affordable & Accessible Housing Options
2. High Cost of Living in the County

“I don't use my upstairs anymore, so I tried to convert it into a rentable ADU. It would be an affordable solution for a small family. I had the plans drawn up but was so frustrated with the permitting costs and process that I gave up.”





Mental Health: Surveys

Mental Wellness Worries Residents Across the County

The first question on the survey aimed to uncover the top-of-mind worries from residents. When asked “how often do you worry about any of the following statements,” residents selected “**the mental well-being of my family, loved ones, or myself**” as “very frequently” **the most**.

Respondents with HHI of \$75k or less, it’s worth noting that “**being able to pay the bills**” came in as the most frequently worried about statement with “**the mental well-being of my family, loved ones, or myself**” landing in the fourth.

22% of respondents with HHI at \$75k or less said mental wellness or counseling services were never accessible to them.








