**RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY  
RESOLUTION 079812 TO DELETE SIX POSITIONS, AND ADD SEVEN POSITIONS;  
AND ACCEPT THE UPDATED REPORT OF BIWEEKLY SALARIES BY  
CLASSIFICATION**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

**WHEREAS**, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

**WHEREAS**, San Mateo County Ordinance No. 073703 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

**NOW THEREFORE, IT IS HEREBY ORDERED** that the Board of Supervisors authorizes an amendment to Master Salary Resolution 079812 as follows:

**SECTION 1:** Part 14 of the Resolution is amended as indicated:

**ORGANIZATION 38000 PLANNING AND BUILDING**

1. Item E002, Administrative Secretary II is decreased by 1 position for a new total of 1 position.

2. Item E003, Administrative Secretary III is increased by 1 position for a new total of 2 positions.

#### 61000 BEHAVIORAL HEALTH AND RECOVERY SERVICES

1. Item G081, Mental Health Program Specialist is decreased by 1 position for a new total of 18 positions.
2. Item D023, Health Services Manager I is increased by 1 position for a new total of 2 positions.

#### 63000 CORRECTIONAL HEALTH SERVICES

1. Item E416S, Medical Office Assistant Series is decreased by 1 position for a new total of 9 positions.
2. Item E414, Patient Services Specialist is increased by 1 position for a new total of 1 position.

#### 66000 SAN MATEO MEDICAL CENTER

1. Item F009S, Patient Care Series is decreased by 1 position for a new total of 378 positions.
2. Item V250, Resource Specialist Patient Financial Services System is decreased by 1 position for a new total of 0 positions.
