ADJUSTMENT TO CONTRACTED PROVIDERS EFFECTIVE JULY 1, 2023, FOR  
FISCAL YEAR 2023-24**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the County contracts with numerous entities to provide vital services to vulnerable members of the community; and

**WHEREAS**, Behavioral Health and Recovery Services has approved a cost-of-living adjustment for FY 2023-24 to support its contractors in response to the continued negative impacts of the COVID-19 pandemic on labor shortages, price increases and supply chain disruptions.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of this Board of Supervisors be and hereby authorizes the Chief of San Mateo County Health or designee to execute contract amendments for each of the contractors listed in Exhibit A in an amount not to exceed 4% of the contract amount for FY 2023-24 allocated to the provision of direct services.


