RESOLUTION 079812 TO DELETE FOUR POSITIONS, ADD FOUR POSITIONS,
AND ADD ONE SPECIAL COMPENSATION; AND ACCEPT THE UPDATED
REPORT OF BIWEEKLY SALARIES BY CLASSIFICATION

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes this Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize this Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 073703 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of this Board of Supervisors.

NOW THEREFORE, IT IS HEREBY ORDERED that this Board of Supervisors authorizes an amendment to Master Salary Resolution 079812 as follows:

SECTION 1: Section 5 of the Resolution is amended as indicated:

ORGANIZATION 39000 PARKS DEPARTMENT

 One Park Ranger I/II assigned specialized multimedia work responsibilities shall receive a 5.74 percent differential pay, in addition to all other compensation. Only one employee may be so assigned D045.

SECTION 2: Section 14 of the Resolution is amended as indicated:

ORGANIZATION 32000 PROBATION DEPARTMENT

- Item D045, Administrative Services Manager I is decreased by 1 position for a new total of 0 positions.
- Item D185, Senior Management Analyst is increased by 1 position for a new total of 1 position.

- 1. Item D088, Program Services Manager II is decreased by 1 position for a new total of 0 positions.
- Item D241, Assistant Director of Emergency Management is increased by 1 position for a new total of 1 position.

- Item E416S, Medical Office Assistant Series is decreased by 1 position for a new total of 2 positions.
- Item E411S, Patient Services Assistant Series is increased by 1 position for a new total of 24 positions.

 Item D093, Custodial Services Manager is decreased by 1 position for a new total of 0 positions. Item D239, Environmental Services Manager-Health and Clinics is increased by
