AMENDMENT FOUR TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND ADVANCED MANAGEMENT AND CONSULTING LLC

THIS AMENDMENT TO THE AGREEMENT, entered into this 12 day of December 2023, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and ADVANCED MANAGEMENT AND CONSULTING LLC, hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement with Advanced Management and Consulting for on-call project and construction management services for multiple capital construction projects in the amount not to exceed of \$600,000 on September 17, 2019; and

WHEREAS, the parties amended the Agreement extend the agreement term through September 9, 2024, and increased the contract value by \$500,000 for a new total contract not to exceed value of \$1,100,000; and

WHEREAS, the parties amended the Agreement to increase the contract value by \$400,000 for a new not to exceed value amount of \$1,500,000; and

WHEREAS, the parties wish to amend the Agreement to increase the contract value by \$1,000,000 for a new not to exceed amount of \$2,500,000 and will follow the previously approved fee schedule as shown in Exhibit B.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section **3. Payments** of the agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reservices the right to withhold payment if County determines that the quantity or quality of the work performed in unacceptable. In no event shall the County's total fiscal obligation under this Agreement exceed TWO MILLION FIVE

HUNDRED THOUSAND DOLLARS (\$2,500,000). In the event that the County makes any advanced payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement.

2. All other terms and conditions of the agreement dated 09/17/2019, between the County and Contractor shall remain in full force and effect.
