**RESOLUTION: 1. ESTABLISHING “4-HOUR TIME LIMITED PARKING” ZONES ALONG EL CAMINO REAL (STATE ROUTE 82) AT VARIOUS LOCATIONS WITHIN THE UNINCORPORATED COLMA AREA AS DEPICTED ON EXHIBIT A; AND 2. ESTABLISHING A “30-MINUTE TIME LIMITED PARKING” ZONE ALONG EL CAMINO REAL (STATE ROUTE 82) WITHIN THE UNINCORPORATED COLMA AREA AS DEPICTED ON EXHIBIT A**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, California Vehicle Code Section 22507 et seq. and Sections 7.24.010 et seq. of the San Mateo County Ordinance Code allow this Board of Supervisors to prohibit or restrict the stopping, parking or standing of vehicles by resolution or ordinance with associated signs and markings in their respective jurisdictions on a state highway if the resolution or ordinance establishing said restrictions are first submitted and approved in writing by the Department of Transportation; and

**WHEREAS**, the Director of Public Works has recommended that “Time Limited Parking” zones be established as noted herein and as depicted on Exhibit A attached hereto; and

**WHEREAS**, parking restrictions may apply to state highways provided the resolution or ordinance establishing said restrictions are submitted and approved in writing by the California Department of Transportation; and

**WHEREAS**, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that:

1. "4-Hour Time Limited Parking" zones be established along El Camino Real (State Route 82) within the unincorporated Colma area at the following locations:

- A) On the westerly side of El Camino Real commencing twenty-three feet (23.0') north of the center line of A Street, extending northerly a distance of 185 feet, more or less, between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, excluding holidays.
- B) On the westerly side of El Camino Real commencing thirty-one feet (31.0') south of the center line of A Street, extending southerly a distance of 100 feet, more or less, between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, excluding holidays.
- C) On the westerly side of El Camino Real commencing one hundred seventy-five feet (175.0') south of the center line of A Street, extending southerly a distance of 66 feet, more or less, between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, excluding holidays.
- D) On the westerly side of El Camino Real commencing three hundred forty-one feet (341.0') south of the center line of A Street, extending southerly a distance of 50 feet, more or less, between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, excluding holidays.

- E) On the westerly side of El Camino Real commencing two hundred sixty-five feet (265'.0) north of the center line of Albert M Teglia Boulevard, extending northerly a distance of 40 feet, more or less, between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, excluding holidays.
  - F) On the westerly side of El Camino Real commencing eighty-four feet (84'.0) north of the center line of Albert M Teglia Boulevard, extending northerly a distance of 116 feet, more or less, between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, excluding holidays.
  - G) On the easterly side of El Camino Real commencing fifty-two feet (52'.0) north of the center line of A Street, extending northerly a distance of 217 feet, more or less, between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, excluding holidays.
  - H) On the easterly side of El Camino Real commencing twenty-four feet (24'.0) north of the center line of B Street, extending northerly a distance of 41 feet, more or less, between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, excluding holidays.
  - I) On the easterly side of El Camino Real commencing one hundred sixteen feet (116'.0) south of the center line of C Street, extending southerly a distance of 88 feet, more or less, between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, excluding holidays.
2. A "30-Minute Time Limited Parking" zone to be established on the easterly side of El Camino Real (State Route 82) commencing thirty-three feet (33.0') north of the

center line of C Street, extending northerly a distance of 74 feet, more or less, between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday, excluding holidays.

3. The Director of Public Works is authorized to send a copy of this Resolution to the California Department of Transportation to review and approve in writing such changes.
