

**First Amendment to Agreement
Between the County of San Mateo and Sutter Bay Medical Foundation, a
California nonprofit public benefit corporation dba Palo Alto Medical Foundation
for Health Care, Research and Education for General Surgery Services**

THIS FIRST AMENDMENT TO THE AGREEMENT for General Surgery Services, entered into this _____ day of _____ 2024, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Sutter Bay Medical Foundation, a California nonprofit public benefit corporation dba Palo Alto Medical Foundation for Health Care, Research and Education, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an agreement for **General Surgery** services for the term of July 1, 2021 through June 30, 2024, in an amount not to exceed \$ 2,843,595.00 (the "Agreement"); and

WHEREAS, the parties desire to extend the term of the agreement by six months at Contractor's request; and

WHEREAS, the amount payable under the Agreement must be increased by \$ 473,934.00 to accommodate the services provided under the extended term;

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. **EXHIBIT B** (entitled **PAYMENTS**) Section VIII. is amended to read as follows:

Unless increased pursuant to Paragraph g. of Section VII. of Exhibit A, total payment for services under this agreement will not exceed NINE HUNDRED FORTY-SEVEN THOUSAND EIGHT HUNDRED SIXTY-FIVE DOLLARS (\$947,865) per year. Over the three year and six month term of this Agreement, the maximum amount payable will not exceed THREE MILLION THREE HUNDRED SEVENTEEN THOUSAND FIVE HUNDRED TWENTY-NINE DOLLARS (\$3,317,529).

2. Section 3.1 of the Agreement (entitled "**Term**") is amended to read as follows:


The term of this Agreement is July 1, 2021 through December 31, 2024.

3. **All other terms and conditions of the Agreement shall remain in full force and effect.**
