AMOUNT NOT TO EXCEED \$52,446.11**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the County has qualified for a grant of federal funds under the Help America Vote Act from the California Secretary of State reimbursing the County for expenses related to polling place accessibility training and associated costs, up to a maximum reimbursement of \$52,446.11; and

**WHEREAS**, this Board has been presented with a copy of the grant agreement, has considered and approved said agreement as to form and content, and desires to enter into said agreement.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the County of San Mateo is authorized to receive the aforementioned reimbursement funds from the California Secretary of State in an amount not to exceed \$52,446.11.

**IT IS FURTHER DETERMINED AND ORDERED** that the Chief Elections Officer, or designee(s), is authorized to execute an agreement with the California Secretary of State to receive said grant funds and may negotiate and/or execute any additional documents necessary to qualify for, implement, and/or carry-out the grant agreement.
