

**AMENDMENT NO. FOUR TO THE AGREEMENT FOR OPERATION
OF THE PESCADERO SOLID WASTE TRANSFER STATION BETWEEN THE COUNTY OF SAN
MATEO AND ALLIED WASTE INDUSTRIES**

THIS AMENDMENT NO. FOUR to that certain Agreement, dated August 12, 2008 by and between the County of San Mateo, hereinafter referred to as "County", and BFI Waste Systems of North America, LLC dba Allied Waste Services of San Mateo County, referred to as "Contractor" and is entered into this 8th day of August 2017;

WITNESSETH:

WHEREAS, the parties hereto entered into an Agreement dated July 31, 2008 on August 12, 2008, whereby Contractor provides services and certain equipment necessary to operate the Pescadero Solid Waste Transfer Station in San Mateo County and to transport and dispose of solid waste and recyclables from said transfer station in accordance with the terms and conditions of said Agreement; and

WHEREAS, the parties hereto wish to amend said Agreement to extend its term and modify the Contractor fee schedule.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section C. Duration of Contract/Termination, Item 1. is hereby amended to add the following: "Pursuant to these extension provisions, the term of this agreement is extended twelve (12) months to include the time period starting August 15, 2017 and ending on August 19, 2018. Upon expiration of the twelve (12) month extension, this agreement may be extended by the parties' execution of a written amendment consistent with the above extension provisions."
2. Exhibits "A" and "B" attached hereto replace the Contractor's fee schedules included in the Agreement and prior amendment.
3. All other terms and conditions of the agreement dated August 12, 2008 between the County and the Contractor shall remain in full force and effect.
