**RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH  
BIGGS CARDOSA ASSOCIATES, INC., FOR ENGINEERING AND  
ENVIRONMENTAL PERMITTING SERVICES, EXTENDING THE TERM THROUGH  
NOVEMBER 30, 2018 AND INCREASING THE AMOUNT BY \$25,000 TO \$231,020**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, this Board of Supervisors did, on November 20, 2012, adopt Resolution No. 072275, which authorized the agreement with Biggs Cardosa Associates, Inc. for engineering and environmental permitting services for the Preventative Maintenance for Various County Bridges Project in the amount of \$145,000; and

**WHEREAS**, the Project consisted of work on the Alpine Road Bridge over San Francisquito Creek, Madera Lane Bridge over El Corte de Madera Creek, and Stage Road Bridge over Pescadero Creek; and

**WHEREAS**, on June 2, 2015, this Board adopted Resolution No. 073835, which authorized an Amendment No. 1 to the agreement to increase the amount by \$61,020 to \$206,020 and extend the term through November 20, 2017; and

**WHEREAS**, on May 16, 2017, this Board adopted Resolution No. 075202, which adopted the plans and specifications for the Preventative Maintenance for Various County Bridges Project, including work on the three bridges specified herein; and

**WHEREAS**, this Board of Supervisors did, on July 11, 2017, adopt Resolution

No. 075339, authorizing an agreement with Myers and Sons Construction, LP for the Preventative Maintenance for Various County Bridges Project , but specifically authorized work on two of the bridges (Alpine Road and Stage Road bridges); and

**WHEREAS**, the bid amount for work associated with the Madera Lane Bridge was considerably higher than anticipated and the Department recommended moving forward with work on the other two bridges and re-advertising the work prescribed for the Madera Lane Bridge; and

**WHEREAS**, Amendment No. 2 to the agreement with Biggs Cardosa Associates, Inc. will provide the additional funding and time necessary for Biggs Cardosa Associates, Inc. to prepare the Madera Lane Bridge Project for re-advertisement and provide support through the bidding and construction process; and

**WHEREAS**, the Director of Public Works is recommending Agreement No. 2 which will extend the term of the agreement from November 20, 2017 to November 30, 2018 an increase the agreement amount by \$25,000 to \$231,000; and

**WHEREAS**, the Board has considered and concurs with the recommendation of the Director of Public Works.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of this Board of Supervisors be and is hereby authorized and directed to execute said Amendment No. 2 with Biggs Cardosa Associates, Inc. for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.
