RESOLUTION AUTHORIZING: A) THE ADOPTON OF A COUNTY FACILITIES PARKING POLICY; AND B) THE DIRECTOR OF PUBLIC WORKS, OR HIS DESIGNEE, TO ISSUE ADMINISTRATIVE PENALTIES AND/OR CITATIONS FOR VIOLATIONS OF THE COUNTY'S FACILITIES PARKING POLICY; AND C) THE DIRECTOR OF PUBLIC WORKS TO MAKE ADMINISTRATIVE AND NON-SUBSTANTIVE CHANGES TO THE COUNTY FACILITIES PARKING POLICY OR UPDATES FOR COMPLIANCE WITH LOCAL, STATE, AND FEDERAL REGULATIONS

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, and it is necessary to establish a policy to more effectively address and ensure public parking spaces are available for County customers, and

WHEREAS, and State law and local ordinances including, California Vehicle
Code Sections 21113 et. al. and 22651.3, and Chapters1.08, 7.28, and 7.32 of the San
Mateo County Ordinance Code collectively allow this Board of Supervisors to establish
parking controls and issue citations for parking violations on County-controlled lots; and

WHEREAS, and the County Facilities Parking Policy will designate certain parking lots, areas of parking, and parking structures, as "no parking zones" between the hours of 1 am until 6 am.

WHEREAS, Violation of the rules or regulations relating to the operation, stopping, standing or parking of motor vehicles on the driveways and grounds of County

Facilities property, duly adopted, and as from time to time amended, by the County's Board of Supervisors, shall be cited and may be towed pursuant to the County's parking ordinance and Section 21113 et seq. and Section 22651, of the Vehicle Code of the State of California, and

WHEREAS, and the Director of Public Works recommends the adoption of a County Facilities Parking Policy and the establishment of "No Parking Hours".

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors ORDERED that effective September 12, 2017 the Board hereby authorizes.

- The adoption of a County Facilities Parking Policy, attached hereto as Attachment A to this resolution.
- The establishment of No Parking Hours at County operated and maintained parking structures and parking lots between the hours of 1 a.m. and 6 a.m., as described in County Facilities Parking Policy.
- The Director of Public Works, or his designee, to issue administrative
  penalties and/or citations for violations of the County's Facilities Parking
  Policy as allowed by the County Ordinance Code.
- 4. The Director of Public Works to make administrative changes and nonsubstantive changes to the County Facilities Parking Policy or updates for compliance with local, state, and Federal regulations.
