**RESOLUTION APPROVING THE ROAD PROJECT LIST TO BE FUNDED WITH THE  
SENATE BILL 1 ROAD MAINTENANCE AND REHABILITATION ACCOUNT FUNDS  
AS SUCH FUNDS HAVE BEEN INCLUDED IN THE SEPTEMBER REVISIONS TO  
THE COUNTY BUDGET FOR FISCAL YEAR 2017-2018 TO BE ADOPTED  
BY YOUR BOARD AT A REGULAR PUBLIC MEETING**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, Senate Bill 1 (SB 1) (Beall, Chapter 5, Statutes of 2017), established a road maintenance and rehabilitation account to address deferred maintenance on the state highway system and on local street and road system; and

**WHEREAS**, SB 1 established requirements for holding local governments accountable for the efficient use of public funds to maintain public streets and roads; and

**WHEREAS**, pursuant to Street and Highways Code (SHC) Section 2034(a)(1), prior to receiving an apportionment of RMRA funds from the State Controller in a fiscal year, a city or county must submit to the Commission a list of projects proposed to be funded with these funds pursuant to an adopted county budget. The project list must include a description and the location of each proposed project, a proposed schedule for each project's completion, and the estimated useful life of the improvement. The project list shall not limit the flexibility of an eligible city or county to fund projects in accordance with local needs and priorities, so long as the projects are consistent with

SHC Section 2030(b); and

**WHEREAS**, the County is anticipated to be eligible for SB 1 funds in the amount of \$3,308,000 in FY2017-2018; and

**WHEREAS**, the specific project list (Road Project List) proposed by the Department of Public Works to be funded by SB 1 is attached hereto as Exhibit "A".

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS**  
as follows:

1. The Road Project List attached as Exhibit "A", hereto, is adopted by this Board as the list of projects to be funded with the Senate Bill 1 Road Maintenance and Rehabilitation Account (RMRA) funds allocated in Fiscal Year 2017-2018.
2. The Road Project List shall be the list of projects to be funded by Senate Bill 1 Road Maintenance and Rehabilitation Account (RMRA) as included in the September Revisions to the County's FY 2017-2018 budget to be adopted by this Board at a regular meeting.
