
AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND THYSSENKRUPP ELEVATOR CORPORATION



WITNESSETH:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for elevator maintenance and repair services at various County Facilities on November 18, 2014; and wish to extend the agreement term date to January 31, 2018.

WHEREAS, the parties wish to amend the Agreement to make changes to the scope of work and include maintenance and repair services for Maple Street Correctional Facility, Coastside Clinic and 306 Spruce Clinic.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1. Amend Exhibit B, Paragraph 1: In consideration of the services provided as described in Exhibit A, contractor shall be paid \$19,866 (nineteen thousand eight hundred sixty six dollars per the table below. Additionally, contractor shall invoice county for all work performed not covered in the standard monthly service in accordance with the terms of the agreement and at the labor rates indicated below.
- Amend Section 4 Term and Termination, Paragraph 1: Subject to compliance with all terms and conditions, the term if this Agreement shall be from December 1, 2014 to January 31, 2018.
- 3. Amend Exhibit B to Include: Elevator Maintenance at Coastside Clinic, Maple Street Correctional Center and 306 Spruce Street Clinic. The table below now replaces Exhibit B Equipment Pricing Table.
- 4. ThyssenKrupp to invoice separately FMO and Health and Hospital for elevator service as outlined in the Equipment Pricing Table.
