RESOLUTION AUTHORIZING THE ABILITY TO CONTRACT WITH PUBLIC SAFETY COMMUNICATION'S RETIRING COMMUNICATIONS CENTER DIRECTOR, JAIME D. YOUNG, PURSUANT TO GOVERNMENT CODE §7522.56(f)(1), AND FINDING THAT THE NATURE OF EMPLOYMENT AND APPOINTMENT IS NECESSARY TO FILL A CRITICALLY-NEEDED POSITION DURING THE 180-DAY POST-RETIREMENT SEPARATION PERIOD.

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Jaime D. Young is retiring November 25, 2017, after serving in the

Office of Public Safety Communications (PSC) for 35.5 years; and

WHEREAS, in the course of her management duties, Ms. Young gained a high

level of expertise in managing complex projects related to public safety operations; and

WHEREAS, it is critical that the current project of procuring highly specialized

equipment for the new San Mateo County Regional Operations Center remain on its

project schedule:

WHEREAS, the specialized equipment that has unique specifications include:

Computer-Aided-Dispatch, Mobile Devices, GIS Mapping and Business Intelligence Systems, which are being vetted by several multi-disciplinary project teams that include personnel from Police, Fire, EMS and other public safety related fields; and WHEREAS, Ms. Young may continue her role as Project Manager of said project for the remainder of this fiscal year;

WHEREAS, Ms. Young will be paid at the rate of \$77.00 per hour as a Contractor and limited to working a maximum of 960 hours for the remainder of the fiscal year; and

WHEREAS, Government Code §7522.56 requires a 180-day separation period as established by the California Public Employees' Pension Reform Act, before re-hiring or contracting with a retired employee unless the entity's governing body makes a finding certifying that the appointment is necessary to fill a critically needed position.

## NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

Board of Supervisors certifies, pursuant to Government Code §7522.56(f)(1), the nature of the employment described above and the requested appointment is necessary to fill a critically needed position in the Office of Public Safety Communications before 180 days have passed given the facts outlined above, and accordingly approves the hiring of Jaime D. Young with PSC in order to accomplish tasks associated with Project Management of the Technology Project already underway.
