**RESOLUTION AUTHORIZING AN AGREEMENT WITH JOEL FAY, PsyD AND LOUISA PARKS, PsyD TO COLLABORATIVELY WORK AS A TEAM TO PROVIDE MENTAL HEALTH SERVICES AND EDUCATION TO EMPLOYEES OF THE SHERIFF'S OFFICE AND PUBLIC SAFETY COMMUNICATIONS AND THEIR FAMILIES FOR THE TERM OF JANUARY 1, 2018 THROUGH DECEMBER 31, 2019, IN AN AMOUNT NOT TO EXCEED \$400,000**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the San Mateo County Sheriff's Office Mental Health Services and Education Program is a progressive approach to building resiliency amongst employees of the Sheriff's Office and Public Safety Communications in the areas of managing, interpreting, and coping with stress-related issues; and

**WHEREAS**, existing contracted providers currently do not provide the desired level of enhanced psychological support for law enforcement employees; and

**WHEREAS**, the Sheriff's Office worked in collaboration with experts from the San Mateo County Health System to select the most qualified psychologists through the Request for Proposal process; and

**WHEREAS**, the Sheriff's Office would like to enter into a contract with Joel Fay, PsyD and Louisa Parks, PsyD for mental health services and education, for a two-year term commencing January 1, 2018, and a not-to-exceed amount of \$400,000; and

**WHEREAS**, Joel Fay, PsyD and Louisa Parks, PsyD will provide mental health services and education and assist with the creation and implementation of an improved mental health and emotional well-being system for personnel in the Sheriff's Office and Public Safety Communications; and

**WHEREAS**, this Board has determined that it is the best interest of the County to enter into an agreement with Joel Fay, PsyD and Louisa Parks, PsyD given they possess the required skills and subject matter expertise to successfully implement the Mental Health Services and Education Program; and

**WHEREAS**, all parties wish to enter into an agreement for mental health services and education to Sheriff's Office and Public Safety Communications employees, for the term of January 1, 2018 through December 31, 2019, in an amount not to exceed \$400,000; and

**WHEREAS**, this Board has been presented with the agreement and has examined and approved it as to both form and content and desires to enter into the agreement.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of this Board of Supervisors be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto; and

**BE IT FURTHER RESOLVED** that the Sheriff or Sheriff's designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by not more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
