SUBJECT: Certification of County Maintained Road System Mileage

RECOMMENDATION:

Adopt a Resolution certifying the mileage in the County of San Mateo's maintained road system to be 315.541 miles as of December 31, 2011 (Project No. R3001, F-331 [3C]).

BACKGROUND:

Section 2121 of the California Streets and Highways Code requires that in May of each year, each county shall report to the California Department of Transportation (Caltrans) "any additions or exclusions from its mileage of maintained county highways." This report typically takes the form of a certification of the total mileage of the County of San Mateo's (County's) maintained road system. Last year's total County maintained road system mileage of 315.382 was reported to Caltrans as 315.39. Your Board has adopted similar resolutions directing the reporting of the total number of maintained miles in previous years.

DISCUSSION

This year, the proposed total County maintained mileage to be reported to Caltrans is 315.541 miles. The mileage numbers will now be reported to the thousandths to be consistent with Caltrans report format. There was an addition of 0.184 miles due to the road measurements taken in 2011 and a reduction of 0.025 miles due to a section of road that was annexed to the City of Redwood City. Exhibit "A" to the Resolution provides the summary of the County of San Mateo Maintained Road Mileage and maps with updated road segments, as of December 31, 2011.

County Counsel has reviewed and approved the Resolution as to form.

Certification of the mileage in the County's maintained road system contributes to the Shared Vision 2025 outcome of a Collaborative Community by assisting the State of California in their calculation for the allocation of gas tax revenues to the local agencies. The County of San Mateo is expecting \$15 Million in gas tax revenue this year. The

Department of Public Works uses these funds to maintain the County of San Mateo's road system for the benefit of the traveling public.

FISCAL IMPACT:

There is no impact to the General Fund. The normal cost for managing the road records annually is approximately \$8,000, which is paid for from this gas tax revenue.

RESOLUTION CERTIFYING THE MILEAGE IN THE COUNTY OF SAN MATEO'S MAINTAINED ROAD SYSTEM TO BE 315.541 MILES AS OF DECEMBER 31, 2011 (PROJECT NO. R3001, F-331 [3C])

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Section 2121 of the California Streets and Highway Code provides that each year counties shall submit to the California Department of Transportation the additions to and deletions from their total mileage of maintained county roads; and

WHEREAS, the California Department of Transportation certified to the State Controller that the total mileage of maintained County roads in the County of San Mateo, as of December 31, 2010, was 315.39 miles; and

WHEREAS, the Director of Public Works has reported that as of December 31, 2011, there was a net increase to the total mileage of maintained County roads during 2011; and

WHEREAS, the Director of Public Works has also reported that as of December 31, 2011, the total mileage of maintained County roads is 315.541 miles.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED based on the information provided by the Director of Public Works, that this Board certifies the

County maintained mileage as described in Exhibit "A", "Summary of County of San Mateo Maintained Road Mileage as of December 31, 2011" attached hereto and made a part hereof, that the mileage of County maintained roads as of December 31, 2011 is certified to be 315.541.


0.184 Additions and 0.025 Deletions to Maintained Road Mileage in 2011


- 1. **EDGEWOOD ROAD (County Road Number 24)** from Canada Road (County Road Number 20) to County Boundary southwest of Yorkshire Lane. 1250, 1252 and 1254 Edgewood Road was annexed to the City of Redwood City by LAFCO File No. 11-01, Resolution 1146. The County maintained mileage has been decreased by 0.025 centerline miles or 132 feet, which reflects the annexation to the City of Redwood City. Total maintained mileage for the specified section of road is 2.805 centerline miles or 14,810.40 feet.
- 2. **MIDDLEFIELD ROAD (County Road Number 29-A)** from County Boundary 85.96 feet west of Flynn Avenue to County Boundary 198.53 feet west of Douglas Avenue (County Road Number 635) was re-logged. The County maintained mileage has increased 0.015 centerline miles or 79.20 feet, which reflects the re-logging. Total maintained mileage for the specified section of road is 0.115 centerline miles or 607.20 feet.
- 3. **MIDDLEFIELD ROAD (County Road Number 29-B)** from northern half of road from Douglas Avenue (County Road Number 635) to Mac Arthur Avenue (County Road Number 740), full width of road from Mac Arthur Avenue (County Road Number 740) to 84.86 feet west of Encina Avenue (County Road 697), and northern half of road from 84.86 feet west of Encina Avenue (County Road 697) to Encina Avenue (County Road 697) was re-logged. The County maintained mileage has increased 0.067 centerline miles or 353.76 feet, which reflects the re-logging. Total maintained mileage for the specified section of road is 0.907 centerline miles or 4,788.96 feet.
- 4. **HAMILTON WAY (County Road Number 442-A)** from County Boundary east of Oakview Way (County Road Number 432) to County Boundary west of Toyon Way was re-logged. The County maintained mileage has increased 0.067 centerline miles or 351.20 feet, which reflects the re-logging. Total maintained mileage for the specified section of road is 0.127 centerline miles or 668 feet.
- 5. **HAMILTON WAY (County Road Number 442-B)** from County Boundary east of Lakeview Way to County Boundary southeast of Eastlake Way (County Road Number 441-B) was re-logged. The County maintained mileage has increased 0.008 centerline miles or 44.80 feet, which reflects the re-logging. Total maintained mileage for the specified section of road is 0.248 centerline miles or 1,312 feet.






- 6. **OAK PARK WAY (County Road Number 457)** from Lakemead Way (County Road Number 461) to end of Oak Park Way at cul-de-sac (County Road Number 457) was re-logged. The County maintained mileage has increased 0.009 centerline miles or 46.87 feet, which reflects the re-logging. Total maintained mileage for the specified section of road is 0.519 centerline miles or 2,739.67 feet.
- 7. **SEVENTH (7TH) AVENUE (County Road Number 561-A)** from Middlefield Road (County Road Number 29-B) to Edison Way (County Road Number 1417) was re-logged. The County maintained mileage has increased 0.002 centerline miles or 8.45 feet, which reflects the re-logging. The total maintained mileage for the specified section of road is 0.412 centerline miles or 2,173.25 feet.
- 8. **SEVENTH (7TH) AVENUE (County Road Number 561-B)** from Fair Oaks Avenue (County Road Number 1416-B) to Bay Road (County Road Number 32-D) was re-logged. The County maintained mileage has increased 0.001 centerline miles or 5.80 feet, which reflect the re-logging. Total maintained mileage for the specified section of road is 0.271 centerline miles or 1,431.40 feet.
- 9. FAIR OAKS AVENUE (County Road Number 1416-A) from Marsh Road (County Road Number 31) to Edison Way (County Road Number 1417) / Ninth Avenue (County Road Number 684-A) was re-logged. The County maintained mileage has increased 0.015 centerline miles or 79.20 feet, which reflect the relogging. Total maintained mileage for the specified section of road is 0.525 centerline miles or 2,772 feet.





