**SUBJECT:** Accept State Funds for the Cooperative Agreement with the California

Department of Transportation (CALTRANS) and JobTrain for the Provision of Transitional Employment for Formerly Incarcerated

Individuals

### **RECOMMENDATION:**

Approve an Appropriation Transfer Request (ATR) in the amount of \$177,308 from Unanticipated Revenue to the County Manager's Office for expenditures related to the cooperative agreement with CALTRANS and JobTrain for the provision of transitional employment of formerly incarcerated individuals.

### **BACKGROUND:**

On February 28, 2012, your Board entered into a cooperative agreement with CALTRANS for \$2,208,658 in State funds to provide transitional employment for Achieve 180 and probationers for the term of March 1, 2012 through February 28, 1014 with a maximum obligation of \$2,140,680. Under the Agreement with the County, JobTrain will administer the transitional employment program for the formerly incarcerated through Achieve 180, a re-entry program for high-risk offenders in the County Jail.

## **DISCUSSION:**

Though the project is fully funded through the CALTRANS grant, the funds are not appropriated in the County Manager's FY 2011-12 Adopted Budget. This ATR will appropriate \$177,308; which is the amount needed to compensate JobTrain for services and cover any administrative costs incurred by the County through fiscal year-end.

County Counsel has reviewed and approved the memorandum as to form and content.

This action contributes to the Shared Vision outcome of a Healthy Community by ensuring that a continuum of care exists for the formerly incarcerated to support successful transition from jail to the community.

# **FISCAL IMPACT:**

The ATR recognizes revenue and appropriates the cost of the agreement and administrative costs for FY 2011-12 in the amount of \$177,308. The revenue and expenditure for FY 2012-13 will be added to the Probation Department's budget through the normal budget process. The project is fully funded through the CALTRANS grant; there is no Net County Cost.
