Subject: Princeton Planning Proposed Scope of Work

Thank you for your presentation and the opportunity to comment on the draft scope of work for the proposed planning update for the greater Princeton area. We appreciate that the issues we raised regarding the M-1 zone and the Princeton shoreline erosion have been included in the expanded scope of work.

If the County should decide to look for opportunities to fast-track any particular issues, we ask that building height limit reductions for the M-1, and the shoreline portion of the W and CCR be included in that effort. The concern is that during the time necessary to complete the update, many planning applications will be completed under the existing regulations to the detriment of our vision for the area.

## Purpose:

- Princeton shoreline erosion studies, coastal access conceptual plans, and shoreline trail alternatives are referenced below. For the purpose of this scope of work, we would like to build on this to identify a preferred solution and an implementation plan to address Princeton shoreline erosion, coastal access, and remediation of unpermitted armoring.
- Protect harbor water quality from urban runoff pollution. Enhance or reintroduce natural systems to improve water quality through marsh filtration.
- In addressing parking, circulation, and infrastructure needs, include all modes of travel, including bike, pedestrian, transit.
- Focus on fishing & marine-related industry in W zone. Give priority to commercial fishing industry.
- Focus on light industrial in M-1 zone – clean industry, artisan, crafts.
- MCC is supportive of programs that promote green building practices, energy efficiency and reduced vehicle miles traveled.
