**RESOLUTION:**

- A) ADOPTING THE PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH PREVAILING WAGE SCALE REQUIREMENTS, FOR THE SAN MATEO COUNTY SMART CORRIDORS PROJECT -- NORTH AND SOUTH SEGMENTS;

- B) AUTHORIZING AN AGREEMENT WITH W. BRADLEY ELECTRIC, INC., IN THE AMOUNT OF \$7,820,470, FOR THE ENTIRE PROJECT, FOR THE SAN MATEO COUNTY SMART CORRIDORS PROJECT -- NORTH AND SOUTH SEGMENTS;

- C) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO EXECUTE SUBSEQUENT CHANGE ORDERS TO GRANT TIME EXTENSIONS FOR PROJECT COMPLETION AND PAYMENT UP TO A MAXIMUM AGGREGATE AMOUNT, NOT TO EXCEED \$782,050, OR APPROXIMATELY 10% OF THE AGREEMENT AMOUNT; AND**
- D) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO FILE A NOTICE OF EXEMPTION FOR A CALIFORNIA ENVIRONMENTAL QUALITY ACT CATEGORICAL EXEMPTION**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, this Board of Supervisors did, on March 29, 2012, adopt Resolution No. 071889, which: (1) approved Amendment No. One to the agreement between C/CAG and the County of San Mateo, (2) directed the Director of Public Works to execute an ownership, operation and maintenance agreement between C/CAG and the County of San Mateo, (3) directed the Director of Public Works to execute an ownership, operation and maintenance agreement between C/CAG, the County of San Mateo, and each of the ten cities in which construction will take place, and (4) directed the Director of Public Works to proceed with advertising for bids, and reporting back to

this Board with recommendations on awarding a contract.

**WHEREAS**, plans and specification, dated June 29, 2012 were prepared and approved by the Director of Public Works for the San Mateo County Smart Corridors Project – North and South Segments; and

**WHEREAS**, a schedule of prevailing wage scales for each craft or type of workman needed to execute these plans and specifications in the locality in which said work is to be performed has been established by the Department of Industrial Relations and has been referred to in said plans and specifications; and

**WHEREAS**, the Department of Public Works did issue a call for sealed proposals to be received at the office of the County Manager/Clerk of the Board of Supervisors, Hall of Justice and Records, 400 County Center, Redwood City, California, until the the hour of 2:30 p.m., Tuesday, July 31, 2012; and

**WHEREAS**, the Department of Public Works did cause the notice inviting sealed proposals to be published three (3) times in the Examiner Peninsula Newspaper Group, a newspaper printed and published in this County, and obtained an affidavit of said publication; and

**WHEREAS**, the Clerk of this Board of Supervisors did, in public on July 31, 2012 at 2:30 p.m., open and examine all sealed bids that were received in the specified time for the doing of the work referred to in said plans and specifications; and

**WHEREAS**, this Board of Supervisors has caused an analysis of said bids to be made by the Director of Public Works of the County of San Mateo, and has, in open session, fully reviewed and considered said sealed proposals and the analysis thereof; and

**WHEREAS**, the lowest responsible bid was submitted by W. Bradley Electric, Inc., in the amount of Seven Million Eight Hundred Twenty Thousand Four Hundred Seventy and 00/100 Dollars (\$7,820,470) based on an estimate of the amount of work to be done; and

**WHEREAS**, Department of Public Works staff has determined that this project qualifies for a Categorical Exemption pursuant to Section 15301(c) of the California Environmental Quality Act (CEQA) Guidelines for Implementation, which provides that repair and maintenance of existing streets and highways is exempt from review.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** as follows:

1. The plans and specifications dated June 29, 2012 for the aforesaid project are hereby approved and are adopted as the plans and specifications to be adhered to in letting and performing the work under a contract for said improvements.
2. It is in the best interest of the County of San Mateo to award the agreement for the San Mateo County Smart Corridors Project - North and South Segments to:

3. The County of San Mateo shall enter into a written agreement with W. Bradley Electric, Inc., for the completion of said work as required by the Plans and Specifications adopted by this Board of Supervisors, as hereinbefore mentioned, which Plans and Specifications are on file in the office of the Director of Public Works of the County of San Mateo.
4. The President of this Board of Supervisors shall be, and is hereby, authorized and directed to execute an agreement with W. Bradley Electric, Inc., for the doing of said work described therein, subject to the Department of Public Works' receipt and approval of the Faithful Performance Surety Bond ("Performance Bond") and the Labor and Material Surety Bond ("Payment Bond") required to be posted by said Contractor with the County of San Mateo in connection therewith.
5. The Director of Public Works is hereby authorized to execute change orders related to said work for time extensions and payment not exceeding \$782,050 in aggregate.
6. All payments to the Contractor shall be in accordance with the Plans and Specifications, and other agreement documents. Aggregate payment to the Contractor shall not exceed Eight Million Six Hundred Two Thousand Five Hundred Twenty and 00/100 Dollars (\$8,602,520) without this Board's approval.
7. The Director of Public Works is hereby directed to file a Notice of Exemption for a CEQA Categorical Exemption for this project.

8. The Clerk of the Board of Supervisors, County of San Mateo, is hereby authorized and directed to attest the signature of the President of this Board of Supervisors to said written agreement.
