AMENDMENT NO. 1 TO THE AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND ULTRAEX, INC.

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on March 30, 2012, the parties entered into an agreement for the term of April 1, 2012 to March 31, 2013, under which Contractor would provide the San Mateo Medical Center (SMMC) with courier and transportation services including deliveries for the "Meals on Wheels" program, transportation of laboratory specimens and patient cash deposits, and other deliveries as needed, with a maximum amount payable thereunder of \$266,000; and

WHEREAS, the parties wish to amend the Agreement to increase the maximum amount payable thereunder by \$166,000 to \$266,000.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1. Paragraph 2. Contract Term
 - 2. <u>Contract Term</u> The term of this Agreement shall be from April 1, 2012 to November 30, 2012, unless terminated earlier by the County.
- **2.** Paragraph 3 of the Agreement is amended to read as follows:
 - 3. Payments In consideration of the services rendered in accordance with all terms, conditions and specifications set forth herein and any Exhibit(s) or attachment(s) attached hereto, County shall make payment to Contractor in the manner specified herein and in Exhibit "B". In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination. The County reserves the right to withhold payment if the County determines that the quantity or quality of the work performed is unacceptable. In no event shall total payment for services

- 3. The current Exhibit A to the Agreement is deleted and replaced in its entirety with the attached revised Exhibit A (Rev. 09/17/12) and Exhibit B (Rev. 09/17/12), which are incorporated by reference into the Agreement as if fully set forth therein.
- 4. All other terms and conditions of the Agreement dated March 30, 2012, between the County and Contractor shall remain in full force and effect.

- 3. Contractor shall provide transportation of pharmacy items from SMMC to Burlingame Long Term Care (BLTC) as scheduled.
- 4. Contractor will also pick up and deliver supplies from and to SMMC, its clinics, and BLTC as needed.
- 5. Contractor will provide daily transportation of patient cash co-pays from SMMC's Accounts Payable departments in San Mateo and the Coastside location to the San Mateo County Controller's office.
