Subject: Amendment One to the FY 2012 Urban Area Security Initiative Grant
Funding Agreement with the City and County of San Francisco

RECOMMENDATION:

- A) Adopt a Resolution authorizing an amendment to the agreement with the City and County of San Francisco for distribution of FY 2012 Urban Area Security Initiative Grant funds, increasing the amount by \$354,603 to \$2,164,623
- B) Resolution authorizing an Appropriation Transfer Request in the amount of \$354,603 from Unanticipated Revenue to Fixed Assets (4/5ths vote required)

BACKGROUND:

The Urban Area Security Initiative (UASI) is a Federal Department of Homeland Security grant that provides resources for the unique equipment, training, planning, and exercise needs of 31 selected national high threat urban areas. The Bay Area UASI is one of the 31 national urban areas and one of four identified in California.

The Bay Area UASI services a population of seven million and is comprised of three core incorporated cities. The geographical area covered by this region equates to approximately 8,800 square miles.

The City and County of San Francisco has been designated to serve as the fiscal agent for the approval authority for UASI funds granted by the Department of Homeland Security (DHS) through the California Emergency Management Agency (CalEMA).

The County has entered into agreements with the City and County of San Francisco for the past eight years in order to receive UASI funding.

On January 29, 2013, the County entered into an Agreement (Resolution No.072363) with the City and County of San Francisco for the distribution of funds to San Mateo

County as part of the FY 2012 UASI Federal Grant, in an amount not to exceed \$1,810,020 and a term commencing December 1, 2012 through January 31, 2014.

DISCUSSION:

Additional funds are being distributed by the Bay Area UASI to purchase a Video Downlink for the Sheriff's mobile command vehicle, Micro Robotic Systems for the County's SWAT Teams, and a Remote Control System to be paired with the Sheriff's Office Bomb Squad's Bobcat Loader which is used to address Vehicle Borne Improvised Explosive Devices (IESs).

County Counsel has reviewed and approved the Resolution and Amendment as to form.

Approval of this agreement contributes to the Shared Vision 2025 outcome of a Collaborative Community by the cooperation of agencies within the County giving both regional and local responders unique and technical equipment resources to ensure the public's safety as well as that of first responders.
