RESOLUTION:

**A) FINDING THAT A LOCAL EMERGENCY EXISTS ALONG RAMONA ROAD;
AND B) AUTHORIZING EXECUTION OF A CONTRACT WITH SOIL
ENGINEERING CONSTRUCTION, INC. FOR THE DESIGN AND CONSTRUCTION
OF IMPROVEMENTS ALONG RAMONA ROAD**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, erosion is actively occurring along Ramona Road in the community of Los Trancos; and

WHEREAS, said erosion has resulted in the loss of roadway shoulder which would normally provide support for the roadway; and

WHEREAS, multiple geotechnical firms have concurred that continued erosion is inevitable and the loss of portions of the roadway ultimately likely if repair work is not expedited and completed prior to the 2013-14 rainy season; and

WHEREAS, the public interest and general welfare will be served by performing the stabilization work as emergency repair work in an expedited manner before the 2013- 2014 rainy season; and

WHEREAS, consistent with Government Code section 8630 and Public Contract Code sections 22035 and 22050, the Board has been presented with substantial evidence supporting the existence of local emergency conditions at

Ramona Road; and

WHEREAS, a contractor must be selected utilizing a streamlined design/build type process in order to construct the soldier beam retaining wall and other improvements necessary to help prevent the loss of portions of the roadway, and to provide protection of lives and property; and

WHEREAS, the Director of Public Works has determined that using Soil Engineering Construction, Inc. to construct a soldier beam retaining wall will be in the best interest of the County in addressing the emergency situation.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

- 1) It is found with regard to Ramona Road that an emergency exists that will not permit a delay resulting from a competitive solicitation for bids, and that emergency repair work in the form of a soldier beam retaining wall is necessary in order to respond to the emergency.
- 2) On behalf of the County of San Mateo, the President of this Board of Supervisors shall be, and is hereby, authorized to enter into a design/build type agreement with Soil Engineering Construction, Inc., for the final design and construction of a soldier beam retaining wall to address the emergency on Ramona Road without a competitive solicitation for bids, which agreement is to provide that all payments to the Contractor shall be in accordance with the plans and other contract documents prepared and consistent with the Director of Public Works' written estimate of work actually done.
