RECOMMENDATION:

Adopt a Resolution:

- A) Adopting plans and specifications, including conformance with prevailing wage scale requirements for the Resurfacing of Various Streets in the Moss Beach, Princeton-by-the-Sea, El Granada, Emerald Lake Hills, Sequoia Tract, West Menlo and North Fair Oaks Areas of San Mateo County; and
- B) Authorizing the Director of Public Works and Parks to call for sealed proposals to be received by June 11, 2013 at 2:30 p.m., in the office of the Clerk of the Board of Supervisors.

BACKGROUND:

On September 11, 2012, your Board adopted Resolution No. 072172, which authorized the Director of Public Works and Parks or his designee to submit an application with the City/County Association Governments (C/CAG) of San Mateo County and the San Mateo County Transportation Authority (SMCTA) to receive funds from the State Local Partnership Program (SLPP) to resurface various streets in the unincorporated areas of San Mateo County. SLPP funds require a dollar for dollar match of local Measure A Transportation funds and must be used for projects that will extend the pavement life by approximately 15 years.

DISCUSSION:

The project involves the application of a thin layer of asphalt concrete to the existing surface of 13 roads (approximately four miles) to help prolong the life of the roads. The list of roads to be resurfaced, their limits, and locations are shown in Exhibit 'A'.

The Department applied for SLPP funds for this project which were allocated by the California Transportation Commission at their May 7, 2013 meeting.

County Counsel has reviewed and approved the Resolution as to form.

Approval of this action will contribute to the Shared Vision 2025 outcome of a Livable Community by improving our roads for the use by the traveling public to support livable connected communities.

FISCAL IMPACT:

Funding for this project is comprised of SLPP funds, matching Measure A transportation funds, and Road Funds for the balance of the construction management and construction contract costs. The project will be initially financed by Road Fund and Measure A Funds as the SLPP funds are received on a reimbursable basis.

The estimated cost of construction is \$2,150,000 and is proposed to be financed as follows:
