Subject: Resurfacing of Various Streets (County Project No. RT211, Project File No. E4904000, Caltrans Project No. SLPPL-5935 (065))

RECOMMENDATION:

Adopt a Resolution authorizing:

- A) An agreement with O'Grady Paving, Inc. for the Resurfacing of Various Streets in the Moss Beach, Princeton-by-the-Sea, El Granada, Emerald Lake Hills, Sequoia Tract, West Menlo and North Fair Oaks Areas of San Mateo County in the amount of \$1,577,465; and
- B) The Director of Public Works to:
 - 1. Execute subsequent change orders to grant time extensions for project completion and payment up to a maximum aggregate amount not to exceed \$157,747, or approximately 10% of the agreement amount; and
 - 2. File a Notice of Exemption for a California Environmental Quality Act Categorical Exemption.

BACKGROUND:

On September 11, 2012, your Board adopted Resolution No. 072172, which authorized the Director of Public Works or his designee to submit an application with the City/County Association of Governments of San Mateo County and the San Mateo County Transportation Authority to receive funds from the State Local Partnership Program (SLPP) to resurface various streets in the unincorporated areas of San Mateo County. SLPP funds require a dollar for dollar match of local Measure A Transportation Funds and must be used for projects that will extend the pavement life by approximately 15 years.

On May 21, 2013, your Board adopted Resolution No. 072548, which adopted plans and specifications, including conformance with prevailing wage scale requirements and calling for sealed bids for the above mentioned project.

DISCUSSION:

On Tuesday, June 11, 2013, bids were accepted for this project and subsequently referred to this office for checking and recommendation. The bid of:

O'Grady Paving, Inc.
2513 Wyandotte Street
Mountain View, CA 94043

at \$1,577,465 was the lowest responsible bid received for the work. The Engineer's Estimate was \$2,150,000. A summary of the bids received is attached as Exhibit "A".

Staff reviewed the bid documents and has determined that the Equal Employment program submitted by O'Grady Paving, Inc., is in accordance with the current Equal Employment Guidelines and that the Contractor complies with the equal benefits and jury duty pay provisions of the County ordinance code.

Department staff has determined that this project qualifies for a Categorical Exemption pursuant to Section 15301(c) of the California Environmental Quality Act (CEQA) Guidelines for Implementation, which provides that repair and maintenance of existing streets and highways is exempt from review. We request your authorization to file a Notice of Exemption for a CEQA Categorical Exemption for this project.

County Counsel has reviewed and approved the Resolution and Agreement as to form.

Approval of this action contributes to the Shared Vision 2025 outcome of a Livable Community by improving our roads for use by the traveling public to support livable connected communities.

FISCAL IMPACT:

The total estimated cost for construction is \$1,735,212, which includes authorization for up to \$157,747 in change orders as the work is bid on a unit price basis. The contingency is used to pay the contractor for any unforeseen conditions not anticipated in the construction agreement documents.

The project is proposed to be financed as follows:

There is no impact to the General Fund.
