## RESOLUTION A) ADOPTING PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH PREVAILING WAGE SCALE REQUIREMENTS FOR THE RECONSTRUCTION OF SCENIC DRIVE IN THE LA HONDA AREA; AND B) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO CALL FOR SEALED PROPOSALS TO BE RECEIVED BY FRIDAY, JULY 26, 2013 AT 10:30 A.M., IN THE OFFICE OF THE CLERK OF THE BOARD OF SUPERVISORS

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on February 12, 2008, this Board adopted Resolution No. 069259, which approved the Engineer's Report concerning improvements including slope stabilization and the reconstruction of Scenic Drive in La Honda. The Resolution also declared the intention of this Board to form an assessment district and to assess parcels within the proposed district for a portion of the cost of improvements; and

WHEREAS, on April 22, 2008, this Board adopted Resolution No. 069359, which authorized the work to complete the formation of the La Honda Landslide Assessment District and the imposition and levying of the assessments to finance the cost of constructing soil stability improvements and reconstructing Scenic Drive and ordered the proposed improvements; and

WHEREAS, on April 22, 2008, this Board also adopted Resolution No. 069360, which authorized the execution of a contract with Soil Engineering Construction, Inc. (SEC) for the final design and construction of the slope stability improvements within the

La Honda Landslide Assessment District; and

WHEREAS, on September 11, 2008, a Negative Declaration pursuant to the provisions of the California Environmental Quality Act (CEQA) was filed in the office of the County Clerk Recorder of County of San Mateo for the improvements which included the slope stability work and the reconstruction of Scenic Drive; and

WHEREAS, on June 29, 2009, SEC completed the construction of the slope stability improvements within the La Honda Landslide Assessment District. Following the heavy rains of the 2010-11 winter, a portion of the area where Scenic Drive is to be reconstructed showed signs of settlement; and

WHEREAS, Department staff did not recommend moving forward with the reconstruction of Scenic Drive until there was adequate assurance that additional soil settlement would not affect the proposed roadway; and

WHEREAS, on October 2012, the Department's geotechnical consultant submitted a report that concludes that the current slope configuration is stable following the dry winter in 2011-2012, however, soil movement could re-activate if groundwater levels rise following a period of above average rainfall; and

**WHEREAS**, Department staff believes that it is appropriate to move forward with the reconstruction of Scenic Drive; and

**WHEREAS**, Department staff, in consultation with County Planning Department and County Counsel has determined that minor changes to the project description for the road work does not generate new impacts and the 2008 negative declaration is still valid; and

WHEREAS, the plans and specifications, dated July 5, 2013 have been prepared and approved by the Director of Public Works for the reconstruction of Scenic Drive in the La Honda Area Project, and said plans and specifications have been filed in the office of the Director of Public Works (the "plans and specifications"); and

WHEREAS, the plans and specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of workman needed to execute the contract.

## NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

- 1. The plans and specifications dated July 5, 2013, for the aforesaid project, which are on file in the office of the Director of Public Works, and to which reference is hereby made for further particulars, are hereby approved and adopted as the plans and specifications to be adhered to in letting and performing the work under a contract for the improvements described therein.
- 2. Said specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of workman needed to execute the contract.
- 3. The Department of Public Works is authorized and directed to issue a call for

sealed proposals and to set the bid opening date and time on or before 10:30 a.m., Friday, July 26, 2013 in the office of the Clerk of the Board of Supervisors in the Hall of Justice, Redwood City, California. Said bids will be received by the Clerk of the Board of Supervisors and then transmitted to the County Manager's Office in said Hall of Justice and be publicly opened and declared.

- 4. The Director of Public Works is authorized to extend the call for bids and bid opening up to sixty (60) calendar days beyond the time and date originally set forth by the Board of Supervisors.
- 5. The Department of Public Works is further directed to cause the Notice inviting sealed bids to be published for two (2) consecutive times in a weekly newspaper of general circulation published in the County, and to obtain an affidavit of said publication, a copy of which shall be placed on file with the Department of Public Works.
