* * * * * * RESOLUTION AUTHORIZING THE ESTABLISHMENT OF NO PARKING DURING SPECIFIED HOURS ZONES TO FACILITATE STREET SWEEPING IN THE BROADMOOR AND SAN MATEO HIGHLANDS AREAS
RESOLVED, by the Board of Supervisors of the County of San Mateo, State of
California, that

WHEREAS, California Vehicle Code Section 22500 et. seq. and Section 7.32.010 of the County Ordinance Code allow the Board of Supervisors to establish no parking during specified hours zones and associated signs and markings; and

WHEREAS, the Director of Public Works has recommended that no parking during specified hours zones be established as noted herein; and

WHEREAS, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

 No parking during specified hours zones be established at the following locations:

BROADMOOR, along the following streets:

 Stewart Avenue, from Maddux Drive to a point approximately 560 feet east of C/L of Ellis Drive.

- South Park Plaza Drive, from Coronado Drive to 87th Street for a distance of approximately 1,000 feet.
- 87th Street, from South Park Plaza Drive to Sullivan Avenue for a distance of approximately 2,335 feet.
- 88th Street, from Washington Street to a point approximately 150 feet east of C/L of Washington Street.
- 89th Street, from Washington Street to a point approximately 510 feet east of C/L of Washington Street.
- 90th Street, from Washington Street to Sweetwood Drive for a distance of approximately 240 feet.
- Washington Street, from Mac Arthur Drive to Sullivan Avenue for a distance of approximately 2,145 feet.
- Village Lane, from Washington Street to Sullivan Avenue for a distance of approximately 1,320 feet.
- Garden Lane, from Washington Street to Sullivan Ave for a distance of approximately 1,320 feet.
- Alder Avenue, from Garden Lane to Village Lane for a distance of approximately 265 feet.
- Edgeworth Avenue, from Garden Lane to Village Lane for a distance of approximately 265 feet.

- Sullivan Avenue, from Garden Lane to Village Lane for a distance of approximately 265 feet.
- Annie Street, from Washington Street to a point approximately 480 feet south of C/L of Washington Street.

SAN MATEO HIGHLANDS, along the frontage of Highlands Elementary School on the following streets

- Bunker Hill Drive, south side only, from Forge Road to Yorktown
 Road for a distance of approximately 790 feet.
- Yorktown Road, west side only from Bunker Hill Drive to Newport
 Street for a distance of approximately 300 feet.
- Newport Street, north side only, from Yorktown Road to Lexington
 Avenue for a distance of approximately 540 feet.
