Subject: On-Call Architectural Consulting Services for Hospital Facilities and Clinics

## **RECOMMENDATION:**

Adopt a Resolution authorizing Agreements with The Design Partnership LLP, Fong & Chan Architects, Hammel, Green and Abrahamnson, Inc., Meeks, Coates + Eaton Architects, Nichols Booth Architects, Inc., and Taylor to provide on-call architectural professional services for hospital facilities and clinics, for the term of August 6, 2013 through August 5, 2016, for a maximum aggregate amount of \$1,800,000.

## BACKGROUND:

The Department of Public Works (DPW) regularly maintains a number of agreements with "on-call" architectural and engineering consulting firms to provide services on "as needed" basis. The "on call" professional service process has expedited numerous County public work projects over the years.

## **DISCUSSION**:

It is anticipated that a significant number of projects will be undertaken within the next three years within the San Mateo Medical Center and satellite clinics. DPW does not have in-house architectural expertise related to the Office of Statewide Health Planning and Development (OSHPD) processes, and relies on consultants to provide this service.

DPW conducted a separate Requests for Proposals (RFP) process to select consultants specific to hospital and clinics, as these services are specialized and subject to OSHPD jurisdictional requirements. A selection committee comprised of interdepartmental staff reviewed and ranked the submissions received from 25 qualified firms, and made recommendations. DPW is submitting these recommendations for "on call" agreements with six such architectural firms.

By executing the agreements, DPW will have the ability to utilize the consultants' expertise with OSHPD requirements and process, for completing certain tasks associated with planning and designing construction related projects, including tasks such as conducting preliminary studies, conceptual and schematic design, space planning and furniture/accessories selection, ergonomics and accessibility solutions, plans and specifications, addressing permitting, and construction oversight.

DPW will issue individual Work Orders that outline the scope of work and a not-toexceed amount to the Consultant. The not-to-exceed amount for the individual Task Orders will vary; however, the cumulative sum of the Work Orders will not exceed the maximum amount of the Agreement. Any increase above the amount or term of the Agreement(s) would be submitted to the Board for approval.

County Counsel has reviewed and approved the Resolution and Agreements as to form.

Approval of the "on-call" Architectural Services agreements contributes to the Shared Vision 2025 outcome of Collaborative Community by reducing the cost and time required to execute major construction and renovation projects in County facilities.

## FISCAL IMPACT:

The cost of these contracts will be paid for through the budgets for the individual projects that are assigned to the consultants, and are generally funded by the Capital Projects Fund or the individual departments requesting the project. The maximum aggregate amount for the six Agreements is \$1,800,000 or \$300,000 per Agreement for the term of August 6, 2013 through August 5, 2016.
