RESOLUTION AUTHORIZING AN AGREEMENT WITH THE LEGAL AID SOCIETY OF SAN MATEO TO PROVIDE LEGAL ASSISTANCE, FAMILY CAREGIVER SUPPORT, CLIENTS' RIGHTS ADVOCACY AND KIDS IN CRISIS PROGRAM SERVICES, FOR THE TERM OF JULY 1, 2013, THROUGH JUNE 30, 2014, IN AN AMOUNT NOT TO EXCEED \$155,559

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, this Board has designated itself as the Area Agency on Aging (AAA) of San Mateo County to carry out programs supporting senior services; and

WHEREAS, on April 9, 2013, your Board approved the AAA FY 2013-14

Update to the Area Plan for Older Adults and Adults with Disabilities, which identifies activities to improve and expand existing services, as well as to develop new programs designed to address current countywide needs, and recommends services to be funded with San Mateo County's Older Americans Act funding allocations; and

**WHEREAS**, in November 2012, Aging and Adult Services issued a Request for Proposals (RFP) for the provision of services for older adults and Adults with Disabilities for the term of July 1, 2013, through June 30, 2015; and

WHEREAS, the RFP Evaluation Committee approved the Legal Aid Society of San Mateo to provide legal assistance and family caregiver support program services to individuals 60 years and older and the County-funded Clients' Rights Advocates and

Kids in Crisis programs to individuals with disabilities and their families for the term of July 1, 2013, through June 30, 2014, in an amount not to exceed \$155,559; and

**WHEREAS**, this Board has examined the agreement and has approved it as to both form and content.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of the Board of Supervisors be and is hereby directed to execute said agreement with the Legal Aid Society of San Mateo for the term of July 1, 2013 through June 30, 2014, for and on behalf of the County, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of the Health System or designee be authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
