

**AMENDMENT TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
JACKSON & COKER LOCUM TENENS, LLC**

THIS AMENDMENT TO THE AGREEMENT, entered into this _____ day of _____, 20____, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and JACKSON & COKER LOCUM TENENS, LLC, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement to provide locum tenens services on December 27, 2013, for the term of January 1, 2014 through February 28, 2014, in an amount not to exceed \$65,436; and

WHEREAS, the parties wish to amend the Agreement to expand the scope by adding two additional psychiatrists, extend the term by ten months to December 31, 2014 and increase the amount by \$734,564 to an amount not to exceed \$800,000.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Paragraph 2, Contract Term, of the agreement is amended, in its entirety, to read as follows:

Contract Term. The term of this Agreement shall be from January 1, 2014 through December 31, 2014, unless terminated earlier by the County.

2. Paragraph 3, Payments, of the Agreement is amended, in its entirety, to read as follows:

Payments. In consideration of the services rendered in accordance with all terms, conditions, and specifications set forth herein and any Exhibit(s) or attachment(s) attached hereto. County shall make payment to Contractor in the manner specified herein and in Exhibit A. In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination. County reserves the right to withhold payment if County determines that the quantity or

quality of the work performed is unacceptable. In no event shall total payment for services under this Agreement exceed EIGHT HUNDRED THOUSAND DOLLARS (\$800,000).

3. The paragraph entitled "General Provisions" in Section 1, Description of Services to be Performed by Contractor, of Exhibit A is amended to read as follows:

When County of San Mateo, San Mateo Health System (County) and Jackson & Coker Locum Tenens, LLC (Contractor) complete and sign a Client Confirmation of Assignment, Addendum to Client Agreement for each psychiatrist, County is engaging Contractor to provide up to three locum tenens psychiatrists, according to the specific terms stated in each addendum.

4. Section 2, Amount and Method of Payment, Paragraph D, of Exhibit A is amended to read as follows:

The term of this Agreement is January 1, 2014 through December 31, 2014. Maximum payment for services rendered under this Agreement will not exceed \$800,000. Invoices will be approved by Deputy Director of Psychiatric Services and paid within 30 days of receipt of accurately completed invoice.

5. **All other terms and conditions of the Agreement dated December 27, 2013, between the County and Contractor shall remain in full force and effect.**
