#### AN ORDINANCE AMENDING ORDINANCE NUMBER 04674

The Board of Supervisors of the County of San Mateo, State of California,

ordains as follows:

**SECTION 1.** Part 5 of the Ordinance is amended as indicated:

# BOARD OF SUPERVISORS - Special Compensation

The Office of the Board of Supervisors may be staffed with three positions. The salary of any individual in any of these three positions may not exceed the top step of the classification plus ten percent provided that the total salaries of the combinations cannot exceed the combined top step salary for two Senior Legislative Aides and one Legislative Aide. This provision supersede the staffing guidelines set forth in Resolution No. 072883 at section 16 under the heading Board of Supervisors. However, any subsequent board resolutions addressing these guidelines may supersede the provision of this Salary Ordinance Amendment.

**SECTION 2.** Part 14 of the Ordinance is amended as indicated:
