### Subject: Amendment to the Agreement with Project Ninety, Inc.

### **RECOMMENDATION:**

Adopt a Resolution authorizing an amendment to the agreement with Project Ninety, Inc. for substance use disorder residential treatment, and criminal justice realignment services, extending the term through June 30, 2015, and increasing the amount by \$2,409,017 to an amount not to exceed \$10,521,741.

# BACKGROUND:

On September 27, 2011, your Board approved an agreement with Project Ninety, Inc. for the term July 1, 2011 through June 30, 2012, to provide alcohol and drug treatment and recovery services for San Mateo County residents. These services are essential to supporting individuals in long term recovery as they progress through all phases of wellness/recovery, including periods of relapse.

On February 14, 2012, your Board approved a first amendment to the agreement adding criminal justice realignment services, providing supervision to formerly incarcerated adults, and increasing the maximum obligation by \$240,000 to a new maximum of \$2,650,263, with no change to the agreement term.

On July 24, 2012, your Board approved a second amendment to the agreement, increasing the maximum obligation by \$2,783,965 to a new maximum of \$5,434,228, and extending the term of the agreement through June 30, 2013.

On September 17, 2013, your Board approved a third amendment to the agreement, increasing the maximum obligation by \$2,678,496 to a new maximum of \$8,112,724, and extending the term of the agreement through June 30, 2014.

# DISCUSSION:

Effective January 1, 2014, San Mateo County residents became eligible for health coverage under the Affordable Health Care Act 2014 through Medi-Cal or through Other Health Care Provider (OHC). Medi-Cal recipients will be eligible for limited substance use disorder (SUD) services under the expanded benefits available through the Drug Medi-Cal (DMC) program. At this time, Behavioral Health and Recovery Services (BHRS) is collaborating with the California Department of Health Care Services to determine the eligibility of contractors seeking to become DMC-certified. Although the contractor has submitted the certification documentation, there have been significant delays. This amendment will allow BHRS to bridge SUD treatment services for providers impacted by the delay in the DMC certification process and/or the providers impacted by the DMC Residential exclusion.

Through this agreement, the contractor provides unique SUD residential treatment services to San Mateo County adult male residents. This contractor serves a population with high rates of homelessness (50% of the participants), criminal justice involvement (71%), and co-occurring mental health diagnoses (25%). Under the Administrative Memorandum B-1, BHRS contracts providing housing services and related supports are exempt from the requirement for a Request for Proposals process. Project Ninety is one of five residential SUD treatment providers in San Mateo County.

The amendment and Resolution have been reviewed and approved by County Counsel as to form.

The contractor has assured compliance with the County's Contractor Employee Jury Service Ordinance, as well as all other contract provisions that are required by County ordinance and administrative memoranda, including but not limited to insurance, hold harmless, non-discrimination and equal benefits.

Approval of this agreement contributes to the Shared Vision 2025 outcome of a Healthy Community by providing individuals and families in San Mateo County with prevention and treatment services to support recovery, which in turn contributes to the health and safety of communities throughout San Mateo County. Successful treatment discharge occurs when a program participant completes his/her treatment/recovery plan goals. It is anticipated that 53% of clients will achieve a successful treatment discharge. This expected improvement compared to the previous year is in part based on the contractor's efforts to improve its individual treatment planning and appropriate program matching.

## FISCAL IMPACT:

The term of the agreement is July 1, 2011 through June 30, 2015. The agreement maximum is being increased by \$2,409,017, to an amount not to exceed \$10,521,741. The amount of \$2,541,537 is included in the BHRS FY 2013-14 Recommended Budget and \$2,334,976 is included in the BHRS FY 2014-15 Recommended Budget. The Net County Cost for FY2013-2014 and FY 2014-15 is \$532,010 and \$614,457, respectively.
