WHEREAS, the Board of Supervisors of the County of San Mateo is authorized to engage the services of professional technical experts; and

WHEREAS, the public interest and general welfare will be served by selecting and using qualified engineering firms for various professional consulting services, including Civil, Geotechnical, Structural, Electrical and Mechanical; and

WHEREAS, the engineering firms ARUP North America Ltd., Bellecci & Associates, Inc., BKF Engineers, Inc., Buehler & Buehler Structural Engineers, Inc., Cornerstone Structural Engineering Group, Creegan + D'Angelo Engineers, Crosby Group, ENGEO Incorporated, Fugro Consultants, Inc., Interface Engineering Inc., Rutherford + Chekene, and Yei Engineers, Inc. are firms each qualified in their

respective engineering disciplines to provide professional consulting services on a variety of projects; and

WHEREAS, the Director of Public Works has recommended that separate agreements be entered into with each of these firms to provide engineering services as may be necessary and under the direction of the Director of Public Works; and

WHEREAS, this Board has considered and concurs with the recommendation of the Director of Public Works; and
