**THE BOARD OF SUPERVISORS, COUNTY OF SAN MATEO, STATE OF CALIFORNIA
DESIGNATING APRIL 21 – 27, 2014, AS
AS SWINGING SKIRTS LPGA CLASSIC WEEK**

WHEREAS, *Swinging Skirts LPGA Classic* is one of the preeminent golf tournaments around the world and this year's event marks the Ladies Professional Golf Association's (LPGA) first return to the Bay Area since 2010, and will be hosted in San Mateo County at the Daly City Lake Merced Golf Club between April 24th and April 27th, 2014; and

WHEREAS, *Skirts LPGA Classic* is an annual event sanctioned by the LPGA, one of the longest running women's professional sports associations in the world, and coordinated by the Republic of China (Taiwan) based *Swinging Skirts Golf Team*, a non-profit organization consisting of both men and women amateur golfers established for the purpose of internationally promoting the participation and prominence of women in the game of golf; and

WHEREAS, *Swinging Skirts LPGA Classic* seeks to recognize the importance of golf, arts and culture in our society and will accomplish this by displaying colorful artwork, cultural designs and sculptures throughout the Lake Merced Golf Club in addition to exhibiting the local fare of the San Francisco Bay Area with area food trucks, businesses and vendors; and

WHEREAS, *Swinging Skirts LPGA Classic* will feature a 144 player field including 122 LPGA golfers, 10 players from the TLPGA, 5 Taiwanese young talents and 5 sponsor exemptions who will participate by wearing colorful kilts in tribute to the founding cultural and tradition of golf, which was started centuries ago in Saint Andrews, Scotland; and

WHEREAS, *Swinging Skirts LPGA Classic* is expected to host some of the top women golf players in the United States, China and throughout the world; and

WHEREAS, *Swinging Skirts LPGA Classic* has grown to become one of the most well respected and well known tournaments in the game of golf, and San Mateo County is proud to be the location selected to host this annual event.

NOW, THEREFORE, BE IT PROCLAIMED that the Board of Supervisors of the County of San Mateo, State of California, hereby designates the week of April 21- 27, 2014 as *Swinging Skirts Ladies Professional Golf Association (LPGA) Week* in San Mateo County. The Board hereby expresses its gratitude and extends sincere wishes to the *Swinging Skirts Classic* for many more years of success.
