RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH SETON MEDICAL CENTER AND THE HEALTH PLAN OF SAN MATEO, EXTENDING THE TERM THROUGH DECEMBER 31, 2014, AND INCREASING THE MAXIMUM AMOUNT PAYABLE BY \$7,200,000 TO \$18,700,000

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Measure A one-half cent retail transactions (sales) and use tax was approved by San Mateo County voters in November 2012; and

**WHEREAS**, in adopting Measure A, this Board identified as County priorities ensuring that hospitals and emergency rooms remain open, and that long term care beds remain available for low income patients; and

WHEREAS, in particular, the Board stated that it was considering the use of general funds from Measure A to provide substantial assistance to Seton Medical Center so that it can continue to provide critical healthcare services in the community; and

WHEREAS, on July 23, 2013, this Board adopted Resolution No. 072695, authorizing an agreement with Seton Medical Center and the Health Plan of San Mateo, whereunder Seton Medical Center agreed, among other things, to continue providing certain safety net medical services to residents of San Mateo County in exchange for

financial support in an amount not to exceed \$11,500,000 for the term of October 1, 2013 through June 30, 2014; and

WHEREAS, the County, Seton Medical Center, and the Health Plan of San Mateo wish to amend the Agreement to extend its term through December 31, 2014 and to increase the maximum amount payable under the Agreement by \$7,200,000, to an amount not to exceed \$18,700,000; and

WHEREAS, this Board has been presented with a form of such Amendment to the Agreement and has examined and approved it as to both form and content and desires to enter into it; and

NOW, THEREFORE, IT IS HEREBY RESOLVED that the President of this

Board of Supervisors be, and is hereby authorized and directed to, execute said

Amendment to the Agreement for, and on behalf of, the County of San Mateo, and the

Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Chief of the Health System or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
