RESOLUTION AUTHORIZING:

A) THE PRESIDENT OF THE BOARD TO EXECUTE AN AGREEMENT WITH HALF MOON BAY GRADING & PAVING, INC., FOR THE ROAD IMPROVEMENTS ON PORTIONS OF DEL MAR, MADRONE AND SAN RAMON AVENUES IN THE SEAL COVE/MOSS BEACH AREA PROJECT, IN THE AMOUNT OF \$358,812; AND B) THE DIRECTOR OF PUBLIC WORKS TO EXECUTE SUBSEQUENT CHANGE ORDERS TO GRANT TIME EXTENSIONS FOR PROJECT COMPLETION AND PAYMENT UP TO A MAXIMUM AGGREGATE AMOUNT NOT TO EXCEED \$35,881, OR APPROXIMATELY 10% OF THE AGREEMENT AMOUNT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, this Board of Supervisors did, on June 3, 2014, adopt Resolution No. 073216, which resolution adopted the plans and specifications (the "Plans and Specifications"), including conformance with prevailing wage scale requirements, and called for sealed proposals for the Road Improvements on Portions of Del Mar, Madrone and San Ramon Avenues in the Seal Cove/Moss Beach Area Project ("Project"); and

WHEREAS, the Deputy Clerk of this Board of Supervisors did, in public on June 24, 2014 at 2:30 p.m., open and examine all sealed bids that were received in the specified time for the doing of the work referred to in said Plans and Specifications; and

WHEREAS, this Board of Supervisors has caused an analysis of said bids to be made by the Director of Public Works of the County of San Mateo, and has, in open session, fully reviewed and considered said sealed proposals and the analysis thereof; and

WHEREAS, the lowest responsible bid was submitted by Half Moon Bay Grading & Paving, Inc., in the amount of \$358,812 based on an estimate of the amount of work to be done; and

WHEREAS, a Coastal Development Permit was approved and an Initial Study/Mitigated Negative Declaration was certified for this Project by the County of San Mateo Planning Commission on April 23, 2014.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

 It is to the best interest of the County of San Mateo to award the agreement for the Road Improvements on Portions of Del Mar, Madrone and San Ramon Avenues in the Seal Cove/Moss Beach Area Project to:

> Half Moon Bay Grading & Paving, Inc. 1780 Higgins Canyon Road Half Moon Bay. CA 94019

2. The County of San Mateo shall enter into a written agreement with Half Moon Bay Grading & Paving, Inc., for the completion of said work as required by the Plans and Specifications adopted by this Board of Supervisors, as hereinbefore mentioned, which Plans and Specifications are on file in the office of the Director of Public Works of the County of San Mateo.

- 3. The President of the Board of Supervisors shall be, and is hereby, authorized and directed to execute an agreement with Half Moon Bay Grading & Paving, Inc., for the doing of said work described therein, subject to the Department of Public Works' receipt and approval of the Faithful Performance Surety Bond ("Performance Bond") and the Labor and Material Surety Bond ("Payment Bond") required to be posted by said Contractor with the County of San Mateo in connection therewith, and the Clerk of the Board shall attest the President's signature thereto.
- 4. The Director of Public Works is hereby authorized to execute change orders related to said work for the time extensions and payment not exceeding \$35,881 in aggregate.
- 5. All payments to the Contractor shall be in accordance with the Plans and Specifications, and other agreement documents. Aggregate payment to the Contractor shall not exceed \$394,693 without this Board's approval.
