## RESOLUTION AUTHORIZING AMENDMENTS TO THE AGREEMENTS WITH STARVISTA AND FRESH LIFELINES FOR YOUTH, INC. TO PROVIDE SERVICES TO AT-RISK AND SYSTEM INVOLVED YOUTH, EXTENDING THE TERM THROUGH JUNE 30, 2015 AND INCREASING THE AGGREGATE AMOUNT BY \$249,600 TO \$915,605

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on December 13, 2011, the Board of Supervisors approved Resolution #71756 with StarVista and Fresh Lifelines for Youth, Inc. for the term of July 1, 2011 through June 30, 2014 with a total obligation not to exceed \$331,400 and \$168,000 respectively; and

WHEREAS, on October 2, 2012, the Board of Supervisors approved Resolution #72203, increasing the original funding allocation for StarVista and Fresh Lifelines for Youth, Inc. with a total obligation not to exceed \$441,600 and \$224,000 respectively, as a result of additional funding from the State; and

WHEREAS, on September 27, 2013, the Juvenile Justice Coordinating Council recommended a contract extension for StarVista and Fresh Lifelines for Youth, Inc.; and

WHEREAS, the agreement extension will allow for continued behavioral treatment for youth in Redwood City of StarVista in the form of the Insights Adolescent Program based on the "Seeking Safety" model of cognitive behavioral treatment and

continued Leadership Training Program and intensive case management in the community of Fresh Lifelines for Youth, Inc.; and

WHEREAS, the County wishes to amend Resolution #72203 to extend the term of agreements with StarVista and Fresh Lifelines for Youth, Inc. through June 30, 2015, and increase the amount by \$165,600 to an amount not to exceed \$607,200 for StarVista and \$84,405 to an amount not to exceed \$308,405 for Fresh Lifelines for Youtn, Inc.; and

WHEREAS, this Board has been presented with the form of these Amendments and has examined and approved it as to both form and content and desires to enter into said Amendments.

### NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of the Board is hereby authorized and directed to execute said Amendments for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Chief Probation Officer or his designee is authorized to execute contract amendments that modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
