RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH GO NATIVE, INC. FOR THE PROVISION OF INVASIVE SPECIES ERADICATION AND NATIVE PLANT RESTORATION AT DEVIL'S SLIDE TRAIL, MAINTAINING THE TERM THROUGH JUNE 30, 2016, AND INCREASING THE AMOUNT BY \$153,768 TO AN AMOUNT NOT TO EXCEED \$253,268

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, County Parks entered into Agreement No. 39000-14-D036 with Go Native, Inc. to provide invasive species eradication and native plant restoration services at Devil's Slide Trail for the term of May 23, 2014 through June 30, 2016 in the amount of \$99,500; and

WHEREAS, greater numbers of jubata grass (*Cordaderia jubata*) colonies, a plant that the California Invasive Plant Count rates as highly invasive, have since been identified; and

WHEREAS, consultation with other land management agencies as to their best practices for effective eradication of jubata grass (*Cordaderia jubata*) and the prevalence of this particular invasive species on surrounding lands demonstrates that a broader and more intensive scope of work is needed; and

WHEREAS, additional grant funding in the amount of \$123,268 is available for

this work; and

WHEREAS, an expanded and enhanced scope of services has been developed with the contractor that would increase the amount of the agreement through amendment by \$153,768 to an amount not to exceed \$253,268; and

WHEREAS, the Parks Director recommends amending the agreement with Go Native, Inc. to provide these expanded and enhanced invasive species eradication and native plant restoration services while developing the long term natural resource management plan for the Devil's Slide Trail; and

WHEREAS, the Board has considered the recommendation of the Parks Director to execute Amendment No. 1 to Agreement No. 39000-14-D036 with Go Native, Inc. for the provision of invasive species eradication and native plant restoration services at Devil's Slide Trail, maintaining the term through June 30, 2015, and increasing the amount by \$153,768 to an amount not to exceed \$253,268.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of this Board of Supervisors shall be, and is hereby authorized to execute Amendment No. 1 to Agreement No. 39000-14-D036 with Go Native, Inc. for the provision of invasive species eradication and native plant restoration services at Devil's Slide Trail, increasing the amount by \$153,768 to an amount not to exceed \$253,268, and the Clerk of the Board shall attest to the President's signature thereto.
