**RESOLUTION: A) CONSOLIDATING THE STATEWIDE GENERAL ELECTION, TO BE HELD ON TUESDAY, NOVEMBER 4, 2014, WITH ELECTIONS CALLED BY THE BAYSHORE ELEMENTARY SCHOOL DISTRICT, BELMONT-REDWOOD SHORES SCHOOL DISTRICT, BRISBANE ELEMENTARY SCHOOL DISTRICT, BURLINGAME ELEMENTARY SCHOOL DISTRICT, JEFFERSON UNION HIGH SCHOOL DISTRICT, LA HONDA-PESCADERO UNIFIED SCHOOL DISTRICT, PACIFICA SCHOOL DISTRICT, RAVENSWOOD CITY SCHOOL DISTRICT, SAN MATEO COUNTY COMMUNITY COLLEGE DISTRICT, SOUTH SAN FRANCISCO UNIFIED SCHOOL DISTRICT, CITY OF DALY CITY, CITY OF EAST PALO ALTO, CITY OF HALF MOON BAY, CITY OF MENLO PARK, CITY OF PACIFICA, CITY OF SAN BRUNO, TOWN OF ATHERTON, TOWN OF COLMA, TOWN OF HILLSBOROUGH, COASTSIDE FIRE PROTECTION DISTRICT, MIDPENINSULA REGIONAL OPEN SPACE DISTRICT, PENINSULA HEALTH CARE DISTRICT, SAN MATEO COUNTY HARBOR DISTRICT, AND SEQUOIA HEALTHCARE DISTRICT; AND B) AUTHORIZING THE COUNTY'S CHIEF ELECTIONS OFFICER TO RENDER SPECIFIED ELECTION SERVICES IN CONJUNCTION THEREWITH.**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, Sections 10400 through 10418 of the California Elections Code authorizes the consolidation of elections that are called to be held on the same day in or within the same territory upon the order of the governing body or bodies calling the elections, the consolidation may be ordered by the County Board of Supervisors upon request, and the consolidated election shall be held in all respects as if it were one election, with the returns being canvassed by the County's Chief Elections Officer; and

**WHEREAS**, absent other arrangements or applicable law, the costs of any school district election shall be borne by the school district holding the election pursuant

to Section 5421 of the California Education Code, and any city or district shall reimburse the County in full for the services performed by the County's Chief Elections Officer in accordance with Division 10 of the California Elections Code; and

**WHEREAS**, the Brisbane Elementary School District, Jefferson Union High School District, La Honda-Pescadero Unified School District, Pacifica School District, Ravenswood City School District, and South San Francisco Unified School District are required to hold regularly-scheduled governing board elections, each named district has notified the County's Chief Elections Officer of the number of seats to be elected and the relevant policies for breaking a tie vote, and each named district is requesting an election as more candidates have filed to run for office in said district than there are seats available; and

**WHEREAS**, pursuant to state law, the Coastside Fire Protection District, Midpeninsula Regional Open Space District, Peninsula Health Care District, San Mateo County Harbor District, and Sequoia Healthcare District are required to hold regularly scheduled governing board elections, each named district has notified the County's Chief Elections Officer of the number of seats to be elected and the boundaries of the district, and each named district is requesting an election as more candidates have filed to run for office in said district than there are seats available; and

**WHEREAS**, pursuant to state law, the governing board of the Bayshore Elementary School District adopted Resolution No. 14-07 giving notice of a special election to be held on November 4, 2014, for the purpose of submitting a parcel tax

measure to District voters and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefor; and

**WHEREAS**, pursuant to state law, the governing board of the Belmont-Redwood Shores School District adopted Amended Resolution No. 1 giving notice of a special election to be held on November 4, 2014, for the purpose of submitting a bond measure to District voters and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefor; and

**WHEREAS**, pursuant to state law, the governing board of the Burlingame Elementary School District adopted Resolution No. 2014-2015-2 giving notice of a special election to be held on November 4, 2014, for the purpose of submitting a parcel tax measure to District voters and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefor; and

**WHEREAS**, pursuant to state law, the governing board of the Jefferson Union High School District adopted Resolution No. 2014-15/4 giving notice of a special election to be held on November 4, 2014, for the purpose of submitting a bond measure to District voters and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefor; and

**WHEREAS**, pursuant to state law, the governing board of the San Mateo County Community College District adopted Resolution No. 14-10 giving notice of a special election to be held on November 4, 2014, for the purpose of submitting a bond measure to District voters and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the District therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Daly City adopted Resolution No. 14-95 giving notice of a regularly scheduled general municipal election to be held on November 4, 2014, for the purpose of electing three city council members for four-year terms and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of East Palo Alto adopted Resolution Nos. 4510 and 4511 giving notice of a regularly scheduled general municipal election to be held on November 4, 2014, for the purpose of electing two city council members for four-year terms and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Half Moon Bay adopted Resolution No. C-2014-28 giving notice of a regularly scheduled general municipal election to be held on November 4, 2014, for the purpose of electing three city

council members for four-year terms and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Half Moon Bay adopted Resolution No. C-2014-29 giving notice of a special election to be held on November 4, 2014, for the purpose of submitting to the Half Moon Bay voters a sales tax and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Menlo Park adopted Resolution No. 6211 giving notice of a regularly scheduled general municipal election to be held on November 4, 2014, for the purpose of electing three city council members for four-year terms and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Menlo Park adopted Resolution No. 6218 giving notice of a special election to be held on November 4, 2014, for the purpose of submitting to the Menlo Park voters a measure relating to the development of the El Camino Real/Downtown area and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Pacifica adopted Resolution No. 29-2014 giving notice of a regularly scheduled general municipal election to be held on November 4, 2014, for the purpose of electing three city council members for four-year terms and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of San Bruno adopted Resolution No. 2014-90 giving notice of a special election to be held on November 4, 2014, for the purpose of submitting to the San Bruno voters a measure relating to the development of the transit corridor area and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the Town of Atherton adopted Resolution Nos. 14-09 and 14-10 giving notice of a regularly scheduled general municipal election to be held on November 4, 2014, for the purpose of electing three city council members for four-year terms and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the Town therefor; and

**WHEREAS**, pursuant to state law, the City Council of the Town of Colma adopted Resolution No. 2014-35 giving notice of a regularly scheduled general municipal election to be held on November 4, 2014, for the purpose of electing two city

council members for four-year terms and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the Town therefor; and

**WHEREAS**, pursuant to state law, the City Council of the Town of Hillsborough adopted Resolution Nos. 14-33, 14-34, 14-35 giving notice of a regularly scheduled general municipal election to be held on November 4, 2014, for the purpose of electing two city council members for four-year terms and requesting that this Board of Supervisors authorize the County's Chief Elections Officer to render specified election services to the Town therefor; and

**WHEREAS**, each of the aforementioned districts and municipalities has requested their respective elections to be consolidated with the November 4, 2014, Statewide General Election; and

**WHEREAS**, the County's Chief Elections Officer is agreeable to providing specified election services as duly requested and enumerated above in conjunction with the Statewide General Election to be held on Tuesday, November 4, 2014; and

**WHEREAS**, in consideration of the services and supplies to be provided by the Chief Elections Officer in conducting said election, the above-named municipalities and districts as required by law will enter into separate agreements with the County's Chief Elections Officer to outline the services to be rendered and to reimburse the County for the costs of said services and supplies.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that (A) the November 4, 2014, Statewide General Election is hereby consolidated with the above-named local elections duly called by their respective governing bodies; and (B) the Chief Elections Officer is authorized to render specified election services in conjunction therewith.
