RESOLUTION AUTHORIZING

(A) APPOINTMENTS OF DIANE N. ZERMENO AS THE YOUTH MEMBER OF THE NORTH FAIR OAKS COMMUNITY COUNCIL FOR A ONE-YEAR TERM COMMENCING OCTOBER 23, 2014 AND JOSE RODRIGUEZ AS THE ALTERNATE YOUTH MEMBER OF THE NORTH FAIR OAKS COMMUNITY COUNCIL FOR A TWO-YEAR TERM COMMENCING OCTOBER 23, 2014; AND (B) MODIFYING THE OPERATIONS OF THE NORTH FAIR OAKS COMMUNITY COUNCIL

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on February 10, 2009, this Board adopted Resolution No. 069914 which provided, among other things, that the membership of the North Fair Oaks Community Council may include up to nine voting members, as well as a non-voting youth member; and

WHEREAS, the North Fair Oaks Community Council has recommended to this Board that the membership of the Council include a youth member and an alternate youth member to participate in Council meetings when the youth member is unavailable; and

WHEREAS, the Council also recommends that the youth member and alternate youth member be included among the voting members of the Council and this Board desires to allow the youth member and alternate youth member to be included among the voting members of the Council ; and

WHEREAS, Diane N. Zermeno is willing to serve as the youth member of the North Fair Oaks Community Council for a one-year term, commencing October 23, 2014 and the Board desires to appoint her to such a term; and

WHEREAS, Jose Rodriguez is willing to serve as the alternate youth member of the North Fair Oaks Community Council for a two-year term, commencing October 23, 2014 and the Board desires to appoint him to such a term.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the North Fair Oaks Community Council's established membership may include a youth member, as well as an alternate youth member who shall participate in Council meetings when the youth member is unable to do so and that the youth member or alternate youth member, when participating in Council meetings, shall be a voting member of the Council.

IT IS HEREBY FURTHER DETERMINED AND ORDERED that Diane N. Zermeno is appointed as the youth member of the North Fair Oaks Community Council for a one-year term, commencing October 23, 2014 and Jose Rodriguez is appointed as the alternate youth member of the North Fair Oaks Community Council for a two-year term, commencing October 23, 2014.
