Subject: Amendment to the Agreement with Samaritan House-Safe Harbor

## RECOMMENDATION:

Adopt a Resolution authorizing an amendment to the Agreement with Samaritan House - Safe Harbor to continue to provide shelter services, increasing the amount by $\$ 61,745$ to an amount not to exceed $\$ 1,221,875$.

## BACKGROUND:

The Human Services Agency has a Memorandum of Understanding (MOU) with the Department of Housing (DOH) to administrate and monitor the public services agreements receiving Community Development Block Grant (CDBG), Emergency Solution Grant (ESG) and the Rapid Re-Housing Grant (RRH).

On June 6, 2014, DOH announced the FY 2014-15 allocations, granting a lump sum of $\$ 353,790$ CDBG, ESG and RRH funds through Human Services Agency to assist six shelters.

## DISCUSSION:

Samaritan House along with five other shelters responded to Notice of Funding Availability (NOFA 2014-15) and applied for the funding offered by DOH for CDBG for the Samaritan House Safe Harbor Shelter. Safe Harbor Shelter is a 90 bed facility that provides emergency (less than 30 days), and transitional ( 30 days to 6 months) shelter beds for single homeless adults over the age of 18 who are residing in San Mateo County.

This amendment will allocate $\$ 61,745$ for FY 2014-15 to Samaritan House Safe Harbor Shelter based on the chart below. The augmentation will help fund three shelter staff/positions (Case Managers) who engage with shelter's supporting services and monitoring clients' safety at Safe Harbor Shelter.

The Contractor has assured compliance with the County's Contractor Employee Jury Service Ordinance, as well as all other contract provisions that are required by County ordinance and administrative memoranda, including but not limited to insurance, hold harmless, non-discrimination and equal benefits. County Counsel has reviewed and approved the amendment to the agreement and the Resolution as to form the Contractor meets the insurance requirements.

Approval of this amendment contributes to the Shared Vision 2025 outcome of a Prosperous Community by providing Case Management and related services to the homeless population (90 residents) of San Mateo County residing at Safe Harbor homeless shelter. It is anticipated that $55 \%$ of those completing the Emergency Program will move to Transitional Program and connecting to eligible services.

*Performance measures for shelters vary and are based on demographics, the barriers of the populations served, the ability of individuals and families to sustain self-sufficiency and the housing costs of the community.

## FISCAL IMPACT:

The term of the Agreement remains the same, July 1, 2013 through June 30, 2016. This Amendment adds $\$ 61,745$ to the existing Agreement for a total obligation of $\$ 1,221,875$. This additional obligation is funded using Net County Cost but is offset with additional Community Development Block Grant (CDBG) funding under the MOU with the Department of Housing. Appropriation for this Agreement is included in the Fiscal Year 2014-15 Adopted Budget.
