BACKGROUND:

This report will provide you with updates on a variety of County initiatives focusing on Public Safety, Health and Human Services, Community Services and Performance, in addition to reports on legislation and issues that require your action. We will also keep you and the public informed about new services, upcoming events and general updates.

DISCUSSION:

Measure A

In preparation for the next round of Measure A applications, my office will be holding two separate informational meetings for departments and community partners interested in applying for funding in FY 2015-16 and 2016-17.

The first informational session will be held for our nonprofit partners on Wednesday, December 10 from 3:00-3:30 p.m. at the Sobrato Center, 350 Twin Dolphin Drive, Redwood Shores. The session will provide nonprofits with an opportunity to ask questions and receive guidance on the Measure A application process and County priority areas.

The second session will be held on Tuesday, December 16 from 1:30-4:30 p.m. at the Human Services Agency, 400 Harbor Boulevard, Building B in Belmont. This will be a Proposer's Conference where County representatives will be available to listen to ideas from organizations interested in applying for Measure A funds, and answer questions about priority areas.

The CMO has partnered with Thrive, the alliance of nonprofits for San Mateo County, to host these informational sessions and get the word out to all interested not for profit groups.
