Subject: Amendment to the agreement with Ravenswood Family Health Center

RECOMMENDATION:

Adopt a Resolution authorizing an amendment to the agreement with Ravenswood Family Health Center to provide outreach and enrollment assistance activities as part of a coordinated Covered California Navigator program, increasing the amount by \$50,000, to an amount not to exceed \$155,304.

BACKGROUND:

Covered California is the state's health insurance marketplace, established as part of California's implementation of the Affordable Care Act. On June 30, 2014, Covered California released a Request for Applications for community-based entities to perform outreach and enrollment assistance to consumers eligible to obtain subsidized coverage. The Health System submitted a proposal for a coordinated outreach and enrollment assistance strategy targeting San Mateo County residents eligible to receive subsidized coverage through Covered California. Ravenswood Family Health Center (RFHC) was included in the HCU proposal as one of HCU's community partners, due to RFHC's success in enrolling Covered California-eligible consumers during the 2014 Open Enrollment period.

DISCUSSION:

On September 15, 2014, Covered California announced that HCU's proposal was selected for a \$300,000 grant. This amendment is to increase funding to RFHC as a community partner on the Covered California grant. RFHC's responsibilities will include promoting health insurance coverage at community events, providing information and in-person assistance to consumers needing help to enroll in coverage, partnering with HCU on outreach and enrollment assistance activities and meeting all reporting expectations outlined in the Covered California Navigator grant.

The amendment and Resolution have been reviewed and approved by County Counsel as to form.

This amendment contributes to the Shared Vision 2025 outcome of a Healthy Community by ensuring that residents enroll in available health insurance. Maximizing health insurance coverage promotes residents' health and financial security by increasing access to needed healthcare and assuring protection from financial ruin if extensive healthcare services are required. It is anticipated that 1,250 residents will enroll in Covered California coverage as a result of these grant-funded activities.

FISCAL IMPACT:
