Subject: Amendment to the Agreement with Senior Coastsiders

RECOMMENDATION:

Adopt a resolution authorizing an amendment to the agreement with Senior Coastsiders to provide congregate nutrition, home delivered meals, information and assistance, and transportation services increasing the amount by \$37,533 to an amount not to exceed \$200,015.

BACKGROUND:

On October 21, 2014, your Board authorized an amended agreement with Senior Coastsiders to provide congregate nutrition, home delivered meals, information and assistance, and transportation services for the term July 1, 2014, through June 30, 2015, in an amount not to exceed \$162,482. This amended agreement was to accommodate the change in funding structures and reporting requirements of Older Americans Act (OAA) funding.

Due to newly available federal funds, Aging and Adult Services (AAS) now wishes to increase the amount of OAA funds to support the services to be provided to older adults and adults with disabilities.

DISCUSSION:

Senior Coastsiders will provide congregate and home delivered meal nutrition services to individuals 60 years and older with an emphasis on those in economic and social need, i.e. low-income minority individuals, older individuals with limited English proficiency, and older individuals residing in rural areas. In addition, Senior Coastsiders will provide nutrition education to promote better health with accurate and culturally sensitive nutrition, physical fitness, and health (as it relates to nutrition) information.

Nutrition counseling will be offered to home delivered meals participants by a dietitian. Senior Coastsiders will also provide information and assistance and transportation services to eligible individuals 60 years and older.

The Resolution contains the County's standard provisions allowing amendment of the County's fiscal obligations by a maximum of \$25,000 (in aggregate).

The amendment and Resolution have been reviewed and approved by County Counsel as to form.

The amended agreement contributes to the Shared Vision 2025 outcome of a Healthy Community by providing congregate nutrition, home delivered meals, information and assistance, and transportation services to older adults and adults with disabilities. Through these and other community-based services funded through the OAA, it is anticipated that 95% of at-risk individuals will be maintained in a least restrictive setting through case management.

FISCAL IMPACT:

The term of the amended agreement is July 1, 2014, through June 30, 2015. The amount is being increased by \$37,533 to a new amount not to exceed \$200,015. The latter increase will be 100% funded by OAA, with no Net County Cost. The \$37,533 has been included in the AAS FY 2014-15 Adopted Budget.
