**Devil's Slide Trail honored**

Congratulations to all involved in making the Devil's Slide Trail project a reality. The American Society of Civil Engineers, Region 9, awarded the project a 2014 outstanding project award in the Bikes and Trails category. The former highway now offers visitors to its multi-use trail dramatic ocean views while walking, biking or horseback riding.

The Parks Department owns the project which was engineered by BKF Engineers. The awards ceremony is March 6, 2015 in San Diego.

**Winter camping underway at Memorial County Park**

Who says camping is just for summer? Following the suspension of summer camping at Memorial County Park last year due to drought conditions, the Parks Department is happily promoting winter and early spring camping at the popular Loma Mar spot. Visitors during this off-season period up to the first week of May include available spaces in the 39-site Azalea Flat campground for tents and camper vans and viewing of

sprouting fungi, yellow-orange banana slugs and steelhead trout making their way back to Pescadero Creek from the ocean to spawn.

## **Public Safety**

### **County working on one-strike massage ordinance**

One strike and you're out – that's the message to illegal massage parlors in San Mateo County that Deputy County Manager Mike Callagy and Supervisor Adrienne Tissier delivered Jan. 16, 2015 to an assembled group of city managers. The two are working on a county ordinance mandating that massage parlors be shut down indefinitely after a single illegal incident. They are asking city managers to bring the idea back to their respective councils for consideration.

## **Health and Human Services**

### **Employment services compliance highest in county history**

San Mateo County's compliance with a state requirement that at least 30 percent of federal assistance recipients participate in a qualified work-related activity is the highest in county history. The work participation rate in SMCWorks has surpassed the state mandate every month except one since April 2014. In fiscal year 2009-2010, the Human Services Agency reported the average compliance rate at only 1.8 percent but preliminary data for November 2014 shows a dramatic shift to 41 percent. HSA credits improvement to a change in the SMCWorks staffing mode, using a sales-model approach with recipients and expanding activities available to them.

### **New Director of Child Support Services named**

A warm welcome to Kim Cagno who has been named San Mateo County's new Director of Child Support Services. Cagno has nearly 20 years experience with the department, previously serving as deputy director.

### **Workshop planned on how-tos of evidence-based practices**

On March 9, individuals and organizations interested in applying for a Community Corrections Partnership Grant can learn "The ABCs of Evidence-Based Practices & How to Apply Them for Funding" at a workshop sponsored by supervisors Warren Slocum and Adrienne Tissier, the Probation Department and the County Manager's Office. Participants will undergo evidence-based practice training conducted by Dr. Natalie Pearl followed by a workshop on the grant application. Dr. Pearl is the National Director of Research for the Geo Group, a rehabilitative services provider in private prisons, halfway houses and day reporting centers, where her responsibilities include developing and implementing performance indicators.
