Supervisor Horsley announced that he participated in the 4H Presentation Day held at College of San Mateo as a judge on February 7, 2015. The kids showcased their presentation skills on subjects of their choice.

Supervisor Tissier announced that the San Mateo County Disaster Preparedness Day will be held on Saturday, June 6 at the San Mateo County Event Center at 10:00 am. Supervisor Tissier also announced that the Age Well, Drive Well will be held on February 11, 2015 at the Senior Coastsiders in Half Moon Bay from 9:00 am to 12:00 pm.

Supervisor Pine announced that the County received a truancy grant of approximately \$900,000 as well as a \$500,000 grant from the Coastal Conservancy for sea-level rise work.
