**RESOLUTION AUTHORIZING THE CHIEF INFORMATION OFFICER OR HIS  
DESIGNEE TO EXECUTE A) AGREEMENTS WITH EACH VENDOR LISTED IN  
ATTACHMENT A TO PROVIDE CONTINGENCY STAFFING SERVICES  
THROUGHOUT THE TERM OF APRIL 14, 2015 THROUGH APRIL 13, 2016, FOR AN  
AGGREGATE AMOUNT TO NOT TO EXCEED \$12,000,000; AND B) AMENDMENTS  
TO THE EXISTING AGREEMENTS WITH AGREEYA SOLUTIONS AND 314E  
CORPORATION ADDING UP TO \$2,000,000 TO EACH AGREEMENT FOR AN  
AGGREGATE AMOUNT NOT TO EXCEED \$11,950,000.**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of  
California, that

**WHEREAS**, the Information Services Department (ISD) released Request for  
Proposals RFP# ISD1825 on December 30, 2014 for contingency staffing services with  
the intent to build a pool of eligible pre-approved vendors that could provide said  
services; and

**WHEREAS**, ISD would like to select from the pre-approved vendors for a  
variety of contingency staffing needs. This would allow ISD to choose a vendor from  
Attachment A list and would authorize the Chief Information Officer or his designee to  
execute agreements, including those over \$100,000, for contingency staffing services  
throughout the term of April 14, 2015 through April 13, 2016, for an aggregate up to an  
amount not to exceed \$12,000,000; and

**WHEREAS**, ISD has two existing agreements with AgreeYa Solutions and 314e  
Corporation for contingency staffing services that will end on June 30, 2015; and

**WHEREAS**, ISD would like the Chief Information Officer or his designee to be

authorized to execute amendments to each agreement with AgreeYa Solutions and 314e Corporation, if needed, in order to allow any existing contractual resources to come to term and avoid any interruptions in services that the resources are providing. Each agreement may be amended up to \$2,000,000, for an aggregate amount not to exceed \$11,950,000; and

**WHEREAS**, this Board of Supervisors has been presented with the form of a Resolution and has examined and approved same as to both form and content, and desires to enter into same.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Board of Supervisors authorizes the Chief Information Officer or his designee to execute agreements with the vendors on Attachment A, including agreements over \$100,000, for contingency staffing services throughout the term of April 14, 2015 through April 13, 2016, in aggregate for an amount not to exceed \$12,000,000 and amendments with AgreeYa Solutions and 314e Corporation adding up to \$2,000,000, for an aggregate amount of \$11,950,000.
