RESOLUTION: A) APPROVING FISCAL YEAR 2015-16 ANNUAL ACTION PLAN; B) APPROVING THE ADDITION OF THE CITY OF SAN MATEO TO THE URBAN COUNTY FOR THE HOME FUND; AND C) AUTHORIZING THE DIRECTOR OF THE DEPARTMENT OF HOUSING OR THE DIRECTOR'S DESIGNEE TO EXECUTE CONTRACTS, AS APPROVED BY COUNTY COUNSEL, FOR THE PROGRAMS AND PROJECTS AS INDICATED IN THE ANNUAL ACTION PLAN

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, pursuant to Title 24 of the Code of Federal Regulations, Section

570.201, regarding the Community Development Block Grant (CDBG) Program, CDBG

assistance may be used to fund eligible activities to be carried out by public agencies or

by private nonprofit entities which are duly organized to undertake community

development; and

WHEREAS the McKinney-Vento Homeless Assistance Act, 42 U.S.C. § 11301,

et seq., provides for the distribution of federal funds, including the Emergency Solutions

Grant (ESG) Program, for homelessness assistance to units of local governments,

including urban counties as defined under the CDBG Program; and

WHEREAS, the National Affordable Housing Act of 1990, 42 U.S.C. § 12701, *et seq.*, provides for the distribution of federal funds through the HOME Investment Partnerships Act (HOME) Program to eligible entities and consortia; and

WHEREAS, the County of San Mateo has formed the San Mateo County HOME Consortium with the City of South San Francisco for the purposes of receiving HOME funds to increase the supply of affordable housing in this County; and

WHEREAS, the United State Department of Housing and Urban Development (HUD) requires that entitlement jurisdictions submit five-year Consolidated Plans and Annual Action Plans for the use of the CDBG, HOME, and ESG funds; and

WHEREAS, the City of San Mateo has expressed an interest in joining the Urban County for the HOME fund; and

WHEREAS, the subject Annual Action Plan represents the third year of the County's Consolidated Plan, approved by the Board in May 2013 for HUD submission; and

WHEREAS, there has been presented to this Board for its consideration and acceptance the FY 2015-16 Annual Action Plan;

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

Board of Supervisors approves and accepts the Annual Action Plan; approves and accepts the entry of the City of San Mateo into the Urban County for the HOME fund, and authorizes the Director of the Department of Housing or the Director's designee to submit the Annual Action Plan, the related certifications, and all understandings and assurances contained therein to HUD, to take all necessary actions in connection with the submission of the Action Plan, including providing additional information as the

United States government may require, and to execute contracts, as approved by County Counsel, for the programs and projects as indicated in the Annual Action Plan.
